Chana K. Akins, Professor, Department of Psychology, College of Arts and Sciences

Dr. Akins' research areas include the etiology of drug and alcohol abuse, alcohol and drug-associated cues and relapse, and alcohol abuse. Dr. Akins is a senior faculty member and has worked in the Provost's Office on faculty development and the WELD program. She would bring considerable expertise and experience to the committee.

Kristine Urschel, Associate Professor, Department of Animal and Food Sciences, Assistant Dean for Instruction, Martin-Gatton College of Agriculture, Food, and Environment

Dr. Urschel's primary teaching responsibility is ASC 325, Animal Physiology.
