This committee advises the Senate.

New definition of Faculty of Record

SR 3.14.3.1.4

Rephrased to comply with Senate 12/2022 action to distinguish routing of badge proposals that are homed inside a college vs. outside of a college; also clarifies academic council only has a role for badges that are homed outside of a college.

SR 3.1.4.3.2.1.1, 3.1.4.3.2.1.2 and 3.1.4.3.1.3

Correct for Senate 5/1/2023 action that specifies badges are not routed to an academic council after approval at college level (or college equivalent level).
