Why is this course being dropped?: AAD 101 Arts Professions was a one-credit course that students were required to take twice, during the course of their studies. It introduced students to various jobs in arts administration, arts administration resources on campus and in the community, and methods of pursuing volunteer opportunities, internships, jobs and graduate school. This course will replaced with AAD 150 Introduction to Arts Administration which will be expanded from one to three credits, and aimed a new students entering the program, and with a new three – credit course AAD 450 which will be aimed at students about to graduate from the program. Therefore the topics formerly covered in AAD 101 will be covered in more depth in the expanded AAD 150 and the new AAD 450 courses.
