1.How does this course provide for timely and appropriate interaction between students and faculty and among students? The course matches traditional versions of this class in all ways: - The course description, learning outcomes and expectations - The content and schedule of assignments and exercises - The draft, review, and final product workflow for creating final projects - The grading assessment, as in the classroom, is determined both by the quality of student work and student participation and engagement throughout the semester By offering this class in a Distance Learning environment, there will be areas in which the student's experience will exceed that of the classroom, including, but not limited to, offering flexibility for various schedules, life circumstances, and learning styles.

3.How is the integrity of student work ensured? Assignment Descriptions

Projects

- A paper describing how a major aspect of copyright law has changed with the advent of digital technology, analyzing their effectiveness and fairness of those changes in relation to key players in the music industry, and projecting how these laws may be forced to change again in the future.
- A paper describing one of the major players in the distribution of music and how their world has
 changed with the advent of digital technology, and projecting how the player's role may need to
 change again due to new developments in the field. (Graduate Students Only)
- Identify a music artist or group that composes new work, describe the ways they are currently
 distributing their work, and develop recommendations on how those methods might be improved.
 You will present these findings in a formal presentation to the class.

Exercises

You will be required to complete several exercises designed to demonstrate that you have completed the unit requirements and assigned readings, and that you comprehend the material. You will be

allowed to submit only one draft of the exercises. Exercises will be graded and returned within one week of their submission.

Discussions

Each week will include discussion topics posted on the readings. You will be required to log into the discussion board, and respond to the topics with your own thoughts, as well as to the thoughts on the topics of your fellow students. Your discussion postings should be courteous, thoughtful, and carefully written. Furthermore, discussions will offer the opportunity to provide and receive peer feedback on projects you are working on or have completed. Your discussion participation will be graded three times throughout the semester.

Submitting Assignments

Students will complete one unit per week. All research papers, exercises and discussions must be submitted through Blackboard by no later than 11:59pm EST on the day they are due. All due dates are posted in Blackboard in the Assignment and Discussion sections, as well as this Syllabus, under the Course Schedule.

Grade: C / 70%-79% Characterization: Average

Explanation: The student demonstrates a grasp of most established concepts, but is rarely original and creative. Their work is adequately researched, organized and presented in a reasonable manner. Additionally, it is technically acceptable, containing some errors and possessing a rudimentary sense of design. Most exercises are submitted in a timely and manner, and meet the assignment's defined goals. The student engages in most discussions by adding commentary to the established conversations.

Grade: D / 60%-69% (Undergraduate Only)

Characterization: Poor

Explanation: The student demonstrates a grasp of some established concepts but is never original and creative. Their work is not well researched, organized and presented. Additionally, it is barely technically acceptable, containing common errors and possessing very little sense of design. - A paper describing how a major aspect of copyright law has changed with the advent of digital technology, analyzing their effectiveness and fairness of those changes in relation to key players in the music industry, and projecting how these laws may be forced to change again in the future.
- A paper describing one of the major players in the distribution of music and how their world has
 changed with the advent of digital technology, and projecting how the player's role may need to
 change again due to new developments in the field. (Graduate Students Only)
- Identify a music artist or group that composes new work, describe the ways they are currently
 distributing their work, and develop recommendations on how those methods might be improved.
 You will present these findings in a formal presentation to the class.

Exercises

You will be required to complete several exercises designed to demonstrate that you have completed the unit requirements and assigned readings, and that you comprehend the material. You will be


