SUBJECT: Changes to the B&E Undergraduate Program

DATE: December 19, 2007

On November 30 the Undergraduate Studies Committee of the Gatton College of Business and Economics passed the following changes. They were then approved by the faculty as a whole at their December 7 meeting. We request that they be approved by the Undergraduate Council.

All of the changes are found on page 147 of the Bulletin.

- Change, "Each student's undergraduate curriculum must have a general education component which comprises at least 50 percent of the total credit hours required for obtaining a bachelor's degree in the Gatton College of Business and Economics." to "Each student's undergraduate curriculum must include at least 60 earned credit hours of courses outside the Gatton College of Business and Economics."

Rationale: Clarity. The requirement is unchanged.

- Drop "Twelve hours of electives must be taken from courses outside the Gatton College of Business & Economics (six of these hours, if taken for a letter grade may be used to satisfy the USP elective requirement.)"

Rationale: Clarity. Students are required to complete 60 hours outside of B&E. This requirement confuses them.

- Change, "Military science (lower division), music performance, and KHP activity courses, and UK 101/102 (one credit courses) do not count for electives." to "Military science (lower division), music performance, and KHP activity courses do not count for electives."

Rationale: This change allows credit for UK 101 which is consistent with other colleges across the University.

- "Other College Requirements: Students must complete one of the following courses:" add B&E 240 Intercultural Business Communication to the list of communication courses.

Rationale: B&E 240 is a communications intensive course comparable to those already listed.

- Move ENG 203 from a B&E pre-major requirement to a B&E graduation requirement.

Rationale: The lack of availability of ENG 203 effectively makes this course a graduation requirement.
