Good morning to you both. I've been trying to investigate further this business regarding the CLM proposal. I was trying to find proof that either the HSM still existed or that it had been purged. I found no information to support either, and was a little stumped. Finally, Jodi Davenport in the Registrar's office said they had a program on the books called Health Service Administration, and the CIP code matches the one you have on the CLM proposal. I wanted to find out from the two of you if HSM was a specialty track within HSA, if HSM was a whole separate program with its own CIP code, or if a name change from HSA to HSM was ever formally put through the Senate and Board or if its name was informally changed

within the College. In short, is Health Service Administration...the program name which is recognized by CPE and the Registrar...the same program as Health Service Management?

I ask only because I'm trying to determine the most appropriate routing for the proposal once I receive word from Undergraduate Council that it has been approved. A name change and curricular revision to a specialty track goes through a less stringent vetting process than a name change and curricular revision to a program.

Thanks for your patience while I go through these thought processes. I'm only trying to anticipate the questions the Senate Council will bring forth so we can make sure they are addressed in advance to aid in the approval process.

I spoke with Rita Wilkie yesterday and she will send a copy of the proposal to Retha Higgs in Phil Kraemer's office so it can make it to the Undergraduate Council.

I finally finished reading the proposal and am impressed with its thoroughness and organization. For what it is worth, it looks great!

Proposal for Bachelor of Health Science in Clinical Leadership and Management (CLM) Attachment #1

Overview

The proposed program change addresses an important need in the health care industry. There are several letters of support and surveys that indicate a need for this type of program.

The program is intended to admit students having an Associate Degree in a health care profession plus one year of post-degree work experience in a health care setting. The degree requirements include

Completion of 39 credit curriculum Completion of USP requirements Completion of 120 credits

Breakdown of 120 credits:

67 credits transferred from Associate Degree

39 major or professional course credits

14 additional credits to be used for completion of USP and fulfilling 120 credit minimum.

The proposal states that a large number of students will be part-time; therefore, classes will initially be scheduled for the evening. Depending on demand, day classes may be added later. There are plans for the courses to be offered by distance learning at two or three sites.

There is no agreement with KCTCS for a 2+2 program.

The application does not list the completion of the Graduation Writing Requirement as part of the degree requirements. Because the Graduation Writing Requirement is strictly not a part of USP, it needs to be added as an additional requirement.

Course Applications

General comments: The following courses are intended to be cross-listed

HSM 351 with CLM 351

HSM 353 with CLM 353

HSM 354 with CLM 354

HSM 355 with CLM 355

HSM 452 with CLM 452

The application for change for each of these courses needs to be modified so that it does not include a new proposed prefix and number (in 2.a.), but rather lists the new prefix in the cross-listed section of the application (3). (I believe the Undergraduate Council can make this change.)

Because this proposed program originally had a different title, the letter that is referred to in the space provided for signature of cross-listed Department Chair refers to use of the HSE prefix instead of CLM. (We are getting an updated letter that states support of the cross listing with the CLM prefix.)

Several of the course change applications indicate that certain prerequisites will be dropped (HSM 260 and CLA 131 will be dropped as prerequisites for CLM 351; HSM 351, STA 291 or STA 370 will be dropped as prerequisites for CLM 353; ACC 201, ACC 202, CH 351, ECO 260, and ECO 261 will be dropped as prerequisites for CLM 355; and HSM 843 will be dropped as a prerequisite for CLM 452). I was told that the prerequisites listed for these courses are not necessary subjects for the individual courses. Rather, they were listed as prerequisites in order to force students to complete pre-major requirements before taking major courses. I have asked for a brief clarification of this for the Council.

CLM 452 - Change

This application has a typo that lists CLM 351 as the course to be cross-listed with HSM 452. Needs to be changed to CLM 452.

CLM 444 – New Course Application needs grading scale and weights

CLM 505 – New Course Application needs grading scale and weights Application needs to distinguish between the expectations of graduates and undergraduates

CLM 445 – New Course Application needs grading weights and scale

Recommend Approval with the following changes:

- Add "completion of Graduation Writing Requirement" to the proposed changes in program requirements.
- Receive letter of approval from cross-listing department for all of the courses that will be cross-listed.
- Receive a statement that addresses the changes in prerequisites in the applications for change in existing course.
- Modify the application for CLM 452 such that it lists CLM 452 as the cross-listed course.
- Cross-out all of the proposed prefixes and numbers in 2(a) of the course change applications because the course
 prefixes are not being changed; the courses are being cross-listed.
- Include the grading scale and weights for CLM 444, CLM 445, and CLM 505.
- A statement that clearly differentiates the expectations of graduate students from undergraduate students for CLM 505.

Re: New Course Approval for CLM 405: Epidemiology and Biostatistics

In February, the Undergraduate Council approved our application for a BHS Degree Program in Clinical Leadership and Management. It included a new course proposal for CLM 505: Epidemiology and Biostatistics (which was to be cross-listed with CSC 605 Epidemiology and Biostatistics).

I did not realize that 500 and 600 level courses could not be cross-listed. Therefore, upon consultation with Dean Lori Gonzalez, it was decided to assign an undergraduate level number to this course - CLM 405. However, a course number change is considered a major revision and, therefore, requires approval of the Undergraduate Council. Since we are nearing the end of the spring semester, in order for our BHS Degree Program in Clinical Leadership and Management to begin this fall, I have requested an expedited review of this 'new' course by the Undergraduate Council.

I realize that Council members are very busy and I apologize for asking you to review this course proposal with a very quick turnaround time, but your assistance is greatly needed and appreciated.
