## Text of E-mail written by Dean Smith on January 27, 2012:

"Larry, (Copy to Ann, Gary, Ron)

Please share these comments with the Committee as they review the proposed suspension of the FCS Ed program. I fully endorse this suspension.

Dr. Vail and I have discussed the significance of the program for several months now. I concur with Dr. Vail that UK should continue to strive to provide opportunities for students pursuing an FCS Education career in Kentucky high schools. We also agree that the current path we are providing has not worked optimally. Concerns include unacceptably low enrollment and a continuing struggle to identify faculty support for advising, teaching supervision, and instruction in FCS Ed.

I want to assure the committee that the discussion did not arise in the context of budget imperatives, nor was my final decision to support suspension based on economic considerations. However, it would be naïve to ignore the extraordinary scrutiny to which low enrollment programs have been subjected. Recently, that scrutiny has intensified enormously. It is not for budget reasons alone, but it is quite clear that degree programs with this level of enrollment are no longer sustainable.

Dr. Vail and I have agreed on a feasible option for meeting our commitment to FCS Education in the future. This is to base an appropriate undergraduate opportunity within an existing undergraduate major choice in HES (or possibly even other college majors). In collaboration with the College of Education, students could then pursue initial certification at the Master's level. This strategy could, and probably should, include development of targeted advising, and enhancing co-curricular and experiential activities for these UG students. Conceivably, this could approach something like a Pre-Vet model. It must also include communication and recruiting of interested students.

This is all easier to say, than to implement on short notice. While Dr. Vail pursues this plan, the most responsible next step is to promptly suspend further admission of students into the existing CTE option.

## **Background on Suspension of FCS-Ed Option of CTE BS Program:**

Family and Consumer Sciences (FCS) has a long and proud history here in Kentucky, both as part of secondary education and extension education. At present, approximately 200 FCS educators are employed at the high school level across Kentucky. In addition, nearly every Kentucky county has an FCS extension education position (in a few cases, more than one). In many ways, one could argue Family and Consumer Sciences has been the foundation on which the School of Human Environmental Sciences was built. Recently, however, undergraduate enrollments in the FCS-Ed option have declined to a point at which sustainability of the program has become doubtful. In mid-2011, there were less than 10 students enrolled, and Dean Smith asked that the program stop accepting new students until its status could be more carefully evaluated. In late 2011,

both of the departments which collaborate in the delivery of FCS-Ed (Family Sciences and Career & Leadership Development) met separately and concluded that suspension of the FCS-Ed option was necessary.

Of course, students in the program, approximately 14 according to the information I have received from Louise Gladstone, will be provided with services they need to complete their degrees. Meanwhile, other students will likely continue to arrive on campus, albeit in small numbers, with an interest in FCS-Ed careers. One option would be for such students to complete an undergraduate degree in a closely related field (for example, Family Sciences), and then to complete a Masters with Initial Certification in Family & Consumer Sciences subsequently. Other options could also be developed as consistent with the option being considered by Vail and Smith.
