4.2.2.1 Admission to College of Nursing [US:4/12/82; US:3/10/86; US:10/14/91; US: 2/13/95; US 4/10/00]

The College of Nursing (CON) enrollment will be composed of four-year students, associate degree nursing graduates and diploma nursing school graduates. Admission to the University does not guarantee admission to the College of Nursing. Preference will be given to Kentucky residents.

Applicants must be in a state of good health enabling them to carry out the functions of the professional nurse. Routinely, each student will be required to obtain a rubella and rubeola titers, and have an annual tuberculin test or chest x-ray.

Progression to upper division courses is regulated so that the total number of full time equivalents at the beginning of the junior year does not exceed 120. Admission criteria for four types of students are presented below:

A. Criteria for Admission to the 4-year BSN Program Include: [US 4/13/98; US 4/10/06]

1. Freshman Student

Students will be admitted as freshman to a prenursing curriculum based on the following criteria:

- (a) high school grade point average of 2.5 or above on a 4.0 scale
- **(b)** meeting criteria for selective admission to the University of Kentucky as established by Rule 4.2.1.1
- **2.** Selection for admission to the nursing curriculum will occur at the sophomore level for all students based on the following criteria:
 - (a) a minimum cumulative grade point average of 2.5;
 - **(b)** a grade of "C" or better in all required prenursing courses;
 - (c) completion of an approved Medicaid Nurse Aid training program.

In addition, any or all of the following information may be evaluated as part of the admission application:

- (d) a writing exercise based on criteria established by the CON;
- **(e)** two letters of reference from individuals who can assess potential for success (e.g. teacher, employer);
- **(f)** an interview with members of the Admissions and Progression Committee, or their designees.

B. Criteria for Admission to the 4-year BSN Program for Transfer Students Include: [US: 4/13/98; US 4/10/00; US 4/10/06]

1. for transfer students with less than 24 hours of college credit, meeting the criteria for entering freshman and a minimum grade point average of 2.5 on all college work attempted as computed by the Office of Admissions;

- **2.** for transfer students with more than 24 hours of college credit, maintaining a grade point average of 2.5 on all college work attempted as computed by the Office of Admissions:
- **3.** grades of "C" or better in all courses required for CON curriculum;

In addition, any or all of the following may be requested as part of the application:

- **4.** a writing exercise based on criteria established by the CON;
- **5.** two letters of reference from individuals who can assess potential for success (e.g., teacher, employer, etc.); and
- **6.** completion of an approved Medicaid Nurse Aid training program;
- **7.** an interview with members of the Admission and Progression Committee or their designee.
- C. Students will be eligible to apply for readmission the College of Nursing after suspension from the College when they meet criteria as stated in Section B 1 and 2 of this policy.
- D. A student who is a registered nurse will be considered for admission to upper division courses in the nursing program based on the following criteria:
 - The applicant must be a registered nurse licensed to practice in Kentucky;
 - 2. an Associate Degree in Nursing from a college accredited by one of the six regional academic accrediting associations with a minimum GPA of 2.5 on a scale of 4.0 on all course work attempted as computed by the Office of Admissions.*

(a) For Associate Degree Nurses

The registered nurse with an associate degree in nursing from a college accredited by one of the six regional academic accrediting associations will be considered for admission with a minimum GPA of 2.5 on a scale of 4.0 in all course work attempted as computed by the Office of Admissions. NOTE: RN licensure is required to progress to the second semester of the curriculum or prior to beginning clinical experiences.

(b) For Diploma Prepared Nurses

The registered nurse who is a graduate of a diploma program will be considered for admission after earning a minimum of 60 college credits which include:

I. Approval of Minutes – Minutes of April 4, 2008 and June 23rd Retreat were approved by unanimous vote.

II. Announcements

- A. Pat Burkhart reviewed items discussed at June 23, 2008 UG Faculty Retreat.
 - 1. Note taking/power point use in classroom
 - a. Faculty agreed at retreat to put power points up on Blackboard and this is being done.
 - b. N861/863 is piloting the use of Cornell Note taking method in their classes for Fall 2008.
 - c. C. Diebold has developed a power point for test taking strategies and has given to UG faculty.
 - 2. Safety of Students/faculty P. Burkhart asked faculty to continue making students and clinical faculty aware of safety tips for traveling to and from clinical sites.

III. Presentation on NCLEX - C. Diebold

- A. C. Diebold and P. Burkhart attended an NCLEX Conference September 7-8, 2008.
 - 1. C. Diebold reviewed Fact Sheet (See attached) that she distributed to faculty regarding NCLEX examinations. Highlights included:
 - ✓ NCLEX may have 75-265 questions; however average number of questions given is 122.
 - ✓ Students are allowed 6 hours to take the exam.
 - ✓ It is possible to fail a content area and still pass NCLEX.
 - ✓ In Kentucky a student must wait 46 days to retake a failed NCLEX exam.
 - ✓ There is no limit to the number of times a student may retake exam.
 - 2. Confidentiality is important
 - ✓ National Council of State Boards of Nursing monitors the internet for posted questions
 - ✓ Students sign a confidentiality statement
 - ✓ Breach in confidentiality can result in criminal actions and revoking of nursing license.
 - 3. There is a detailed test plan on line for educators to use as a tutorial for students.
- IV. Beginning Faculty Dialogue on "Bridging the Preparation-Practice Gap K. Wagner explained that UG faculty would be addressing issues raised in this two-volume publication as it relates to CON's curriculum and reported that today was the beginning of an ongoing dialogue. K. Wagner reported that in this published report, nursing schools and practice community were asked if the schools were producing proficient nursing students. The practice community described the newly graduated nursing student as deficient in certain areas, particularly related to patient care "management." Faculty engaged in discussion with highlighted comments below. Each faculty member received a copy of the 2-volume publication.

Page 2 UG Faculty Minutes September 19, 2008

- A. Clinicals faculty agree clinicals in college are not "real world" because most students work a 4-6 hour shift and care for only one patient. NUR 871, Medical-Surgical course, has begun using 12 hour clinicals to acclimate students to the working climate they will face upon graduation.
- B. Faculty brainstormed on how to provide a better clinical experience for students. Some suggestions were:
 - ✓ Share information from publication with institutions/agencies to partner with them on clinical learning experiences for students
 - ✓ Meet with the agency representatives to brainstorm about strategies
 - ✓ Form advisory committee, possibly institutional managers and new graduates.
- C. This topic will be continued (led by K. Wagner) in future meetings.

V. Committee Reports

A. UPC - Karen Butler

1. UPC in its meeting earlier today approved changes in NUR 869 course description and objectives and brings recommendation to UG Faculty for a vote. Changes are based upon evaluation of NUR 869 in Spring semester, 2008.

ACTION ITEM – UPC recommends that Undergraduate Faculty approve the changes in course description and objectives for NUR 869. Undergraduate Faculty voted unanimously to approve the course description and objectives for NUR 869.

2. L. Walmsley and P. Burkhart will send forward the proposal to the Health Care Colleges Council.

B. USAP – Jessica Wilson

- 1. USAP in its meeting earlier today approved changes in to the RN-BSN Option (see attachment) and brings recommendation to UG faculty for a vote. Changes are based upon an evaluation of the RN-BSN program by a task force charged with examining the RN-BSN Option and making recommendations as appropriate. Recommendations are:
 - Changes needed in University Bulletin regarding RN-BSN program to reflect current practice.
 - a. In Spring 2008, USAP approved an exemption for completion of university requirements prior to admission for Fall Semester.
 - b. RN-BSN students must however, complete USP before graduation.
 - c. A result of exemption is that enrollment for Fall 2008 increased from 20 students in past semesters to 43.
- 2. Student may be admitted into the program without having a license but must have license before progressing 2nd semester. Rationale: Some students may not have license before Fall because they are still completing 120 clinical hours mandated by Kentucky Board of Nursing.
- 3. Diploma prepared nurses will be considered for admission after earning a minimum of 60 hours from a regionally accredited college, or by submission of a portfolio of RN licensure and experience to the RN-BSN coordinator.
- 4. Recommend March 1st deadline for applications (so that resource needs can be addressed) but

- also consider applications after deadline on a space available basis.
- 5. Change NUR 854 Advanced Concepts in Professional Nursing from a 4 hour to a 5 hour course. Rationale: Course has changed to meet the University's writing requirement.—[This recommendation will be deferred due to impending changes in the DNP option impacting on MSN students in the NUR 854 course].
- 6. Based on RN-student feedback, recommend changing delivery model to ½ semester format for nursing courses: NUR 514 Advanced Health Assessment, NUR 872 Clinical Reasoning, NUR862 Pharmacology, and NUR 864 Pathophysiology. Change NUR 862 to on-line format. Rationale: Student feedback suggested making these courses ½ semester, would allow more in-depth focus and would alleviate deadline pressures by not have all three courses at one time. Faculty teaching these courses concurred.

ACTION ITEM: - USAP recommends to UG Faculty that UPC approved changes to RN-BSN Option be approved by Undergraduate Faculty. Undergraduate Faculty voted unanimously to approve changes to the RN-BSN Option.

C. Undergraduate Nursing Activities and Advisory Council (UNAAC) - F. Hardin-Fanning

- 1. UNAAC will have their annual back-to-school bash but renamed this year "Boo-Bash" since it is occurring in late October (Oct. 29). Students will be dressing in costume and F. Hardin encouraged faculty members to do so.
- **D. Kentucky Association of Nursing Students** J. Hall reported that KANS struggles with enrollment.
 - 1. J. Hall proposed to faculty that a fee be collected through student fees with an approximate increase in fees of \$20 per semester.
 - 2. Discussion ensued.
 - a. Faculty were opposed to assessing any more fees to students.
 - b. Group discussed different ways of promoting KANS.
 - 3. Faculty voted 18 to 2 not to approve fee assessment for KANS.
 - a. L. Walmsley, V. Hensley, and F. Hardin volunteered to work with J. Hall to discover ways to promote KANS.

E. Student Services Advising Group – J. Davis/T. Grace/S. Simpson

- T. Grace distributed handout on attributes of the millennium generation and made presentation on student remediation plans. He reported that personality traits such as 1) lack of initiative,
 trouble concentrating, and 3) lack of creativity contribute to the students' chance for failure. Faculty discussion ensued as faculty explored boundaries for when and how to help students.
- 2. J. Davis reported a new course for pre-nursing majors is being piloted this semester, UK 101 for Nursing. Student Service Advisors are teaching this course to pre-nursing students. Course is to socialize pre-nursing students to nursing and rigors of curriculum.
- 3. S. Simpson reported the new initiative of Wednesday night guided study groups for prenursing students are going well. The first week there were 48 students; with a drop in 2nd and 3rd weeks.

I. Welcome and Approval of Minutes - K. Butler called the meeting to order. Karen welcomed two students who were in attendance and asked them to introduce themselves. May 2, 2008 minutes were approved as read. Gina Lowry suggested that UPC minutes be approved electronically. This method will be piloted with the current minutes and adopted if members respond and participate in electronic approval.

II. **Announcements**

- **A.** Bev Hilton B. Hilton made the following announcements:
 - 1. The library has new CINAHL.
 - 2. Lab computers were changed to VISTA. There were interfacing problems with students' home computers. Library is in the process of changing computers back to X-P for Windows.
- B. K. Butler reminded UPC that per by-laws, each year a non-clinical faculty member serves on UPC. This year the rotation is for NUR 866 to be a member. Jennifer Cowley will fill the role.

III. New Business

- A. Course Evaluations for 2008-2009 K. Wagner reported that NUR 881,883, 885 and 886 will be evaluated this year (2008-2009) using the streamlined course evaluation process. The evaluation will be based on the 9 essentials from AACN. However not every course will address each essential.
 - 1. The following faculty volunteered to be external reviewers:
 - a. NUR 881 Psych/Mental Health Gia Mudd
 - b. NUR 883 Public Health Gina Lowry
 - c. NUR 885 High Acuity Jennifer Cowley
 - d. NUR 886 Synthesis Claudia Diebold
 - 2. Course committees will complete a self-assessment return to K. Wagner to be discussed at the November UPC meeting.
 - 3. Course Mapping K. Wagner will be meeting with all Course Coordinators to do "curriculum" mapping". Group discussed possibility of a one day retreat during "dead week".
- B. Cultural Competence Workshop C. Gordy initiated discussion regarding pros and cons of student attendance at the University sponsored cultural competency workshop.
 - 1. This year's workshop was problematic:
 - a. workshop held on different day than originally advertised and workshop was held on a class day, rather than clinical day; workshop was not videotaped; lunch was not provided to students.
 - b. M. Lanham and Celeste Cross (students) stated they believed nursing students would rather learn how cultural competence is involved with nursing.
 - 2. UPC discussed whether nursing faculty could make attendance to this workshop mandatory. University Ombudsman said if it was mandatory it would have to be listed in schedule book.
 - 3. After much discussion, K. Butler asked C. Gordy to work with D. Anderson and R. Staten to find a solution regarding: a) mandatory issue; b) incentives to attending; c) alternative solutions such as an "in-house" workshop, and bring back to UPC.

- C. Clinical Site Evaluations K. Butler reminded UPC members that College of Nursing now have new process in place for faculty to evaluate clinical sites. This form was distributed last Spring. UPC agreed an annual evaluation was sufficient. Peg Teachey will send the evaluation form to Course Coordinators late March or early April to give to clinical faculty. Course coordinators will be responsible for tracking clinical faculty compliance of this annual task.
- **D.** RN-BSN Program Gina Lowry reported on review of the RN-BSN program by a task force charged with examining the RN-BSN Option and making recommendations as appropriate (See attached handout). Highlights from the recommended changes include:
 - 1. Changes needed in University Bulletin regarding RN-BSN program to reflect current practice.
 - **a.** In Spring 2008, USAP approved an exemption for completion of university requirements prior to admission for Fall Semester.
 - b. RN-BSN students must however, complete USP before graduation.
 - c. A result of exemption is that enrollment for Fall 2008 increased from 20 students in past semesters to 43.
 - 2. Student may be admitted into the program without having a license but must have license before progressing 2nd semester. **Rationale:** Some students may not have license before Fall because they are still completing 120 clinical hours mandated by Kentucky Board of Nursing.
 - 3. Diploma prepared nurses will be considered for admission after earning a minimum of 60 hours from a regionally accredited college, or by submission of a portfolio of RN licensure and experience to the RN-BSN coordinator.
 - 4. Delete March 1st deadline. Rationale: Applicants are considered on a space available basis.
 - 5. Change NUR 854 Advanced Concepts in Professional Nursing from a 4 hour to a 5 hour course. Rationale: Course has changed to meet the University's writing requirement.
 - 6. Change type of delivery to ½ semester format for nursing courses: NUR 514 Advanced Health Assessment, NUR 872 Clinical Reasoning, NUR862 Pharmacology, and NUR 864 Pathophysiology. Change NUR 862 to on-line format. Rationale: Student feedback suggested making these courses ½ semester, would allow more in-depth focus and would alleviate deadline pressures by not have all three courses at one time. Faculty teaching these courses concurred.
 - 7. Gina Lowry called for a vote on the recommended changes to the RN-BSN program. C. Diebold made a motion to accept the changes as presented and Carrie Gordy seconded it. Motion approved unanimously.

ACTION ITEM: - UPC recommends to UG Faculty that UPC approved changes to RN-BSN program be approved by Undergraduate Faculty.

E. Course Evaluations Online – Brenda Ghaelian and Nancy McDevitt presented process for having students complete an evaluation of course on line. Much discussion followed regarding issue of giving a student an "incomplete" if evaluation is not completed. UPC agreed to continue discussion on this process at a later meeting.
