Why is this course being dropped?: The reason for dropping CHE 572 is manifold. (1) CHE 572 001 and 002 are being replaced by CHE 372 and CHE 472. (2) CHE 572 is listed as 500-level for no reason. The content is more appropriate for the 300 and 400-level. (3) CHE 572 001 and CHE 572 002 were two courses with DIFFERENT content, and different prerequisites, course descriptions and syllabi. Splitting CHE 572 to two courses is the correct course of action. (4) CHE 572 in two sections means the class is not easily scalable. UK Chemistry is growing; we will likely have to create two sections of CHE 372 followed by the creation of 2 sections of 472. (5) The content of CHE 572 was retooled to meet the GCCR; this was seen as an excellent opportunity to get the house in order, create new content, new syllabi, new courses and make the split. (6) The discontinuation of CHE 572 should synchronize with the creation of CHE 372 and CHE 472.
