The final round of voting for the election of a Faculty Trustee is now complete. There was a strong voter turn-out, with 51% of the eligible voters casting votes. Of the 1074 votes cast, the number of votes cast for each candidate is shown below.

According to the University Senate Rule 1.5.2.C

"any candidate who receives a majority of votes will be elected."

No candidate received a majority of the votes cast. In such case, according to University Senate Rule 1.5.2.C

"The second choice votes on the ballots whose first choice candidate or candidates have been eliminated will be added to the first choice votes received by the top two (2) candidates, and the person with the larger number of total votes will be elected."

Using this calculation, candidate Robert Grossman received a majority of the votes cast (481+40 = 521 vs. 422+62=484), and therefore he is declared as being elected as Faculty Trustee, to fill the seat that is opening July 1, 2014 for a three year term that ends June 30, 2017.

I ask that you on behalf of the University Faculty please inform the Chair of the UK Board of Trustees of this election result. I will be soon forwarding a copy of this announcement to the University Faculty.

We also greatly appreciate the high quality of University service exhibited by both candidates in their participation in this important election process.
