Course Description:

A 2 credit hour course covering the methods and techniques necessary for identifying common wood species. Topics include macroscopic wood properties, hardwood and softwood structure, and the systematic thought processes for successful identification of 27 wood species.

Prerequisites:

None

Course Availability:

The course is open to any student who is not a University of Kentucky forestry major. UK forestry majors must take FOR 260 on campus.

Student Learning Outcomes:

Upon completion of this course students will be able to identify and define the component cells that make up various types of wood and will be able to differentiate the cell types and patterns found in various woods. Finally, students completing this course will be able to identify 27 different species of wood in a systematic manner.

Course Goals and Objectives:

This course is designed to provide students with the necessary practical skills needed for successful wood identification. While it is designed to fit within a traditional forestry curriculum, its utility is not limited to this single application. Students from a wide range of disciplines such as architecture, design, and materials science, as well as students with an interest in woodworking will find this course useful.

Required Materials:

No specific text is required (subject to change as the course is designed). Students will need to purchase a kit containing wood specimens, a knife for clean end cuts and a hand lens for studying details.

Organization of Material:

The course is divided into three broad lecture topics and five laboratory components as follows:

- 1. Macroscopic Character of Wood
- 2. Softwood Structure
- 3. Hardwood Structure
- Lab 1 red oak, black walnut, eastern white pine, sassafras, yellow-poplar
- Lab 2 black locust, hard (sugar) maple, Douglas-fir, white oak, American elm
- Lab 3 American beech, birch, soft (red) maple, honeylocust, eastern hemlock
- Lab 4 Kentucky coffeetree, hickory, American sycamore, eastern redcedar, sweetgum
- Lab 5 red mulberry, ash, blackgum, Osage-orange, southern yellow pine, black cherry, balsa

Three graded homeworks (one for each topic area) worth 5% each

Two Exams worth 15% each

Two lab exams worth 15% each

Lab Final worth 25%

Summary Description of Course Assignments:

The homeworks will be open book. They are designed to make sure students have a solid understanding of the material in each topic before moving on to the next.

The exams worth 15% will be closed book and one hour in length

The lab exams will involve wood identification. Since sending each student physical test specimens will be logistically impossible, students will receive digital images of wood species. All features necessary for correct identification will be included. Students will be required to not only correctly identify the species, but will have to outline the flow of logic that led them to their species identification.
