# Proposal for Graduate Certificate in Vocal Pedagogy

#### WHO IS SERVED

In order to increase marketability in higher education and be prepared to meet the challenges of teaching voice in the 21st Century, the Graduate Certificate in Vocal Pedagogy is intended primarily for students pursuing a Master of Music (MM) and Doctor of Musical Arts (DMA) degrees in Voice and Choral Conducting who wish to gain more experience and expertise in the science and art of teaching. The proposed certificate could also be pursued by: 1) college and high school choral conductors interested in vocal health and production; and 2) graduate students in Communication Disorders in the College of Health and Science looking to increase their knowledge and understanding of the singing voice.

Many new openings in higher education look favorably toward those candidates with secondary areas of expertise and especially pedagogical training. This certificate could be pursued concurrently with the regular MM and DMA degree program of the School of Music.

#### ADMISSION INTO CERTIFICATE CURRICULUM

Students who wish to be admitted into this certificate curriculum should have been already admitted into the MM or DMA program. New students should follow Graduate School guidelines for admission first. In addition, a committee consisting of members of the voice faculty and a music faculty member outside the vocal area will interview certificate applicants. This interview will include an appraisal of the student's basic knowledge of anatomy and physiology of the singing voice, standard repertoire for male and female voices, and a basic amount of keyboard proficiency. The student's scores on graduate entrance exams will also be assessed.

The certificate will require a total of 15 hours

The Certificate will be awarded upon completion of the requirements. Students working on the Certificate must earn a grade of **B** or higher in each of the courses required.

For students who may be interested in conducting research involving human participants, it is strongly recommended to take MUS 600 Research I.

All vocal faculty members would be involved in the implementation of the curriculum to some degree since students will be assigned to a studio for individual lessons, and students will choose to observe lessons in several studios.

It is appropriate and timely for the University of Kentucky to offer a Graduate Certificate in Vocal Pedagogy since the Communication Disorders in the College of Health and Sciences, and the College of Medicine have several faculty members actively engaged in vocal research, and one of the vocal area faculty members holds a DMA in Performance and Pedagogy.
