#### **Course Description**

KHP 473, This course is intended to provide students with an overview of the management practices utilized in the sport and fitness industry. Sport Management will include learning opportunities related to planning & organizing; staffing; directing; and networking associated with managing a sport or fitness program. This course reinforces the College of Education's conceptual framework of, "research and reflection for learning and leading".

The methods in which the Management of Sport applications are presented in this course are based on a strong foundation of *research*. *Research* findings from the entire field of contemporary sport management create the design of this course, opportunities in the profession, and feature a great knowledge base.

*Reflection* is heavily emphasized and encouraged in this course. The student will be expected to apply basic methods from the sport management opportunities perspective, reflect on methods learned and refine how he/she applies these methods in his/her respective professions.

Learning is part of the conceptual framework because the students are committed to his/her own learning and have the ability to discuss their own knowledge. The student will explore ways to formulate, provide a way to enhance, and learn through research methods.

Leading is an expectation of faculty and is an outcome that faculty promotes among his/her students through intense preparation. In this course the students will learn how to apply, relate, and communicate information, as well as become a leader with high expectations.

#### **Required Course Readings**

This course requires reading across multiple sources. This includes Pedersen & Thibault's *Contemporary Sport Management 5<sup>th</sup> edition.* We will also rely on the most recent content available for each of the core topics of study. Students will be expected to read articles, cases, and online resources from various entities.

#### **Required Instructional Technology**

This course requires the use of information technology: Students are expected to have regular access to a personal computer and the Internet. Most assignments are to be completed within designated sections of the course Canvas.

#### **Class Attendance Policy**

Attendance is expected for every class. The instructor will take attendance during every session. Students missing class due to an excused absence are responsible for any missed work during the absence. Unexcused absences will result in the loss of points (10% per day late) for assignments missed. Students will have 2 "free" absence in which no excuse is needed but you will still have to submit any assignment for that day. Any unexcused absence beyond that 2 "free" absence will result in a loss of 5 points off of the final grade. If a student misses 20% of the class sessions, that student shall have the right to petition for a "W" or the faculty member may require the student to take an "I" for the course. #### **University Absentee Policy**

It is the interpretation of the Senate Rules and Elections Committee that the clause in Senate Rule 5.2.4.2 ("trips for participation in intercollegiate athletic events") does not apply to students that are University employees of the Athletics Department or Campus Recreation Department who are not participating as team athletes in an intercollegiate athletic event during the missed class.

Students need to notify the professor of absences prior to class when possible. Students may be asked to verify their absences in order for them to be considered excused. If the contracted work is not completed satisfactorily, the "I" grade converts automatically to an "E" (a failing mark). UK and KHP rules require students requesting an "I" grade to complete a contract specifying how and when the "I" will be removed within the calendar year. The contract must be submitted to me before an "I" grade can be issued. Incomplete work and missing assignments will be assigned "E" grades if the student does not submit a complete Incomplete Grade Contract by the course deadline.

#### **Class Participation**

Students should be prepared to actively participate in the facilitation of assigned readings and lectures.

#### **Assignments, Evaluation, and Grading Policy**

#### Syllabus Quiz (On paper)

5 points

Each student is required to **print** the syllabus from Canvas and bring it to class. An open syllabus quiz will be given one week into the beginning of class. Students will not be allowed to use electronic devices to for this quiz.

#### Journal entries (via Canvas)

4 @ 5 points=20

Students will be asked to respond to various journal topics throughout the semester. Due dates are posted in the syllabus. This should be a 1-page response to the question presented. Points will be deducted for grammar errors. Journals will be submitted in Canvas.

#### Exams (On paper)

3 @ 100 points=300

During the course of the semester we will have 2 exams. Exams may contain multiple choice items, true/false items, and listing items. The third exam (Final Exam) is cumulative.

#### **Individual article discussion (In person, in class)**

10 points

On the first day of class students will sign-up for a date to discuss an article of their selection. On the day of your article discussion you will give the class an overview of your article and describe the article's importance to sport management. This should last a minimum of 5 minutes and should include a couple of questions for the class to answer. No paper is required for this discussion.

#### Group research proposal, presentation, and paper

125 points total

Students will be randomly assigned into groups of 3-4 to formulate a research proposal, presentation, and paper. The purpose of this project is to synthesize information about current events/issues in sport/fitness and articulate that information to the class. Students

are required to make a contract (**via Google Docs**) detailing the responsibilities for the group project. At minimum, the contract should include duties/responsibilities of the group members and their signatures. Contracts due in Canvas (**TBD**)

#### Group Presentation Proposal (via Canvas)

25 points (Due: TBD)

A 2-page overview of what you plan to do and how you plan to do it. Should include a prediction/hypothesis of what you think you will find. One person from each group will present this proposal to the class and get feedback.

#### Proposal Points breakdown

10 point for content (Is there a clearly defined issue? Does the group use examples to increase awareness?)

10 points for format (Is the proposal written in paragraph form? Does the group use concepts of APA formatting? Does the group meet the 2-page minimum?) 5 points for spelling & grammar (Should have minimal use of pronouns. Should be written in future tense. Should not include any contractions.)

#### Sport manager observation (In person, on location) 15 points

#### **Course Description**

KHP 473DL, This course is intended to provide students with an overview of the management practices utilized in the sport and fitness industry. Sport Management will include learning opportunities related to planning & organizing; staffing; directing; and networking associated with managing a sport or fitness program. This course reinforces

the College of Education's conceptual framework of, <u>"research and reflection for learning and leading".</u>

The methods in which the Management of Sport applications are presented in this course are based on a strong foundation of *research*. *Research* findings from the entire field of contemporary sport management create the design of this course, opportunities in the profession, and feature a great knowledge base.

*Reflection* is heavily emphasized and encouraged in this course. The student will be expected to apply basic methods from the sport management opportunities perspective, reflect on methods learned and refine how he/she applies these methods in his/her respective professions.

Learning is part of the conceptual framework because the students are committed to his/her own learning and have the ability to discuss their own knowledge. The student will explore ways to formulate, provide a way to enhance, and learn through research methods.

Leading is an expectation of faculty and is an outcome that faculty promotes among his/her students through intense preparation. In this course the students will learn how to apply, relate, and communicate information, as well as become a leader with high expectations.

#### **Required Course Readings**

This course requires reading across multiple sources. This includes *Contemporary Sport Management 5th edition*. We will also rely on the most recent content available for each of the core topics of study. Students will be expected to read articles, cases, and online resources from various entities.

Class participation will be assessed through participation in online discussions and forums. If students must miss a scheduled (synchronous) class meeting, then they must notify me about the reason for the absence **before it occurs**. In the event of **emergency absences** (e.g., personal illness, major accident, death of family member), students should notify me as soon as possible, **preferably through email communication**. Additional assignments may be required for missed virtual synchronous class meetings in regard to unexcused absence. Students have 7 days to produce necessary documentation for excused absences and will be allowed to submit work upon return. Please note that students employed full-time should inform their employer about the class attendance policy and class calendar. Students that determine their work commitments will cause excessive absences should not enroll in the course.

#### **University Absentee Policy**

It is the interpretation of the Senate Rules and Elections Committee that the clause in Senate Rule 5.2.4.2 ("trips for participation in intercollegiate athletic events") does not apply to students that are University employees of the Athletics Department or Campus Recreation Department who are not participating as team athletes in an intercollegiate athletic event during the missed class.

Students need to notify the professor of absences prior to class when possible. S.R. 5.2.4.2 defines the following as acceptable reasons for excused absences: (a) serious illness, (b) illness or death of family member, (c) University-related trips, (d) major religious holidays, and (e) other circumstances found to fit "reasonable cause for nonattendance" by the professor.

Students anticipating an absence for a major religious holiday are responsible for notifying the instructor in writing of anticipated absences due to their observance of such holidays no later than the last day in the semester to add a class. If attendance is required by the class policies elaborated in the syllabus or serves as a criterion for a grade in a course, and if a student has excused absences in excess of one-fifth of the class contact hours for that course, a student shall have the right to petition for a "W", and the

Instructor of Record may require the student to petition for a "W" or take an "I" in the course. [US: 2/9/87; RC: 11/20/87]

Students may be asked to verify their absences in order for them to be considered excused. Appropriate notification of absences due to university-related trips is required prior to the absence.

**Incomplete Grades.** Incomplete grades for this course are issued reluctantly and sparingly. The UK Graduate School permits students **one calendar year-unless a shorter time frame is determined mutually by the student and instructor-**to remove an "I" grade. If the contracted work is not completed satisfactorily, the "I" grade converts automatically to an "E" (a failing mark). UK and KHP rules require students requesting an "I" grade to complete a contract specifying how and when the "I" will be removed within the calendar year. The contract must be submitted to me before an "I" grade can be issued. Incomplete work and missing assignments will be assigned "E" grades if the student does not submit a complete Incomplete Grade Contract by the course deadline.

#### **Class Participation**

Students should be prepared to actively participate in the facilitation of assigned readings and lectures during synchronous meetings.

#### **Assignments, Evaluation, and Grading Policy**

### Journal entries (via Canvas)

Students will be asked to respond to various journal topics throughout the semester. Due dates are posted in the syllabus. This should be a 1-page response to the question presented. Points will be deducted for grammar errors. Journals will be submitted in Canvas.

#### Exams (via Canvas)

During the course of the semester we will have 2 timed exams. Exams may contain multiple choice items, true/false items, listing items, and short answer items. The third exam is cumulative. Access codes will be given prior to the exam date.

#### **Individual article discussion board post (via Canvas)**

10 points

On the first day of class students will sign-up for a date to write a discussion post based on a peer-reviewed journal article of their selection. Students will start a thread in "Discussions" for the class on the due date of their article discussion. On the day of your article discussion you will give the class an overview of your article and describe the article's importance to sport management.

Individual article discussion board post responses (via Canvas) 5 @ 3 points=15 Students will be assigned randomly selected dates to respond to individual article discussion posts. Responses should include whether or not you are in agreement with writer's response, in regards to the article's importance to sport. Students will be professional and respectful of the opinions of others.

#### Group Research proposal, presentation, and paper

125 points total

Students will be randomly assigned into groups of 3-4 to formulate a research proposal, presentation, and paper. The purpose of this project is to synthesize information about current events/issues in sport/fitness and articulate that information to the class. Students are required to make a contract (**via Google Docs**) detailing the responsibilities for the group project. At minimum, the contract should include duties/responsibilities of the group members and their signatures. Contracts due in Canvas (**TBD**)

#### Group Presentation Proposal Paper & Video

25 points (TBA)

A 2-page overview of what your group plans to do, how you plan to do it, and what you think you will find. One person from each group will submit a video of the proposal to the instructor for feedback. Youtube videos should be a 3-5 minute overview of the proposal (emailed to instructor). Video links will then be posted in Canvas for peerfeedback.

#### Proposal Points breakdown

10 point for content (Is there a clearly defined issue? Does the group use current examples to increase awareness?)

10 points for format (Is the proposal written in paragraph form? Does the group use concepts of APA formatting? Does the group meet the 2-page minimum?) 5 points for spelling & grammar (Should have minimal use of pronouns. Should be written in future tense. Should not include any contractions. Should not include misspellings or grammatical errors)

#### Video Presentation of Research

**50 points (Selected dates)** 

Each group will develop a contract (**via Google Docs**) for the development of the research presentation. Not all group members have to be in the video. In the contract, members will determine their roles in "planning", "staffing', "directing", and "evaluating". The contract will be submitted to the instructor via email. The presentation outline is as follows:

- \*Should provide the following:
  - \*Introduction to the topic (What are you discussing?)

Students will select a sport manager and answer various questions about the sport manager. The questions will be answered based on observation only. You do not have to meet with the sport manager directly but will just need to answer the questions and submit them in Canvas. (**Due: TBA**)

#### **Sport manager interview (via Canvas)**

#### 15 points

Students will select a sport manager (cannot be the same as used for observation) and ask them various questions about their life/career in sport. You will have to arrange the interview and submit responses through Canvas. (**Due: TBA**)

#### Facility critique (via Canvas)

#### 15 points

Students will select a facility to examine with a critical eye. This will include assessments on safety, accessibility, and organizational structure. You will have to arrange a location and submit the responses through Canvas. (**Due: TBA**)
