1.How does this course provide for timely and appropriate interaction between students and faculty and among students? Does the course syllabus conform to University Senate Syllabus Guidelines, specifically the Distance Learning Considerations? Courses are offered synchronously to students enrolled on the UK campus in Lexington and the UK Center of Excellence in Rural Health (CERH) in Hazard. As such, CERH students will be able to interact with fellow faculty and students during scheduled lecture times. In addition, Canvas communication tools, such as the discussion board, will be utilized as a means of communicating with students and among themselves. The announcements tool is often used to share class wide information with all MLS students. Email will also be used as a means of private and/or mass communication. Course materials will be available to all students via Canvas. In addition, all MLS lectures are Echo recorded and all students in the course are able to view as necessary. The syllabus for MLS 471 conforms to Senate Guidelines for DL considerations.

2.How do you ensure that the experience for a DL student is comparable to that of a classroom-based student's experience? Aspects to explore: textbooks, course goals, assessment of student learning outcomes, etc. The same syllabi will be used for all MLS students regardless of delivery format or location. Course goals, student learning outcomes, textbooks, course expectations, assessments, and grading will be identical for all students. The assignments will be as identical as possible however slight modifications are made to accommodate MLT to MLS students in which the course is 100% online. Lecture syllabi, materials, assignments, and grade book will be available on the course Canvas site. The course will be delivered by a faculty member at one of the sites and simultaneously delivered to the other site using interactive video. Class lectures will be Echo recorded and can be viewed by any student enrolled in the course.

COURSE DESCRIPTION
