MUC 191 Rationale

With the increased undergraduate enrollment at UK, there is increased interest in participating in UK's Symphony Orchestra (MUC 191). Because of this high demand, a second section of MUC 191 is now being taught each semester. The two ensembles play different orchestral literature. Some music majors choose to play their primary instrument in MUC 191 001, and a secondary instrument in MUC 191-401. This gives them the opportunity to play a variety of literature and enhances their experience on multiple instruments. Therefore, the MUC 191 course needs to be repeatable during the same semester as long as it is identified by a different section number.

COURSE DESCRIPTION: Students who have demonstrated the required ability are given an opportunity to study and perform standard orchestral literature. May be repeated eight times for a total of eight credits. A different section of MUC 191 may be taken simultaneously.

PREREQUISITE: Audition and permission of the instructor.

COURSE OBJECTIVES: Gain a greater understanding of the skills required to perform in a high level symphonic ensemble, and to communicate the fundamental emotions of humanity to others through the collaborative expression of music; gain increased understanding of the creative process of the music's creation, both in the compositional stage, and in the rehearsal process by the performers; gain an increased knowledge of the methods of musical preparation and performance practices of the world's great orchestras, conductors and soloists; explore the relationship between western art music and citizenship, the aesthetic value of art music, and its impact on our society.

STUDENT LEARNING OUTCOMES:

At the completion of this course students will be able to:

- (1.) Demonstrate a high level of professionalism and preparation in rehearsals and performances.
- (2.) Demonstrate the ability to rehearse in a collaborative, positive, and professional manner.
- (3.) Demonstrate a high level of concentration, commitment, technical execution, listening and responsiveness during performances.

Students in the orchestra will fulfill the course objectives by demonstrating a high level of professionalism and preparation in rehearsals; by demonstrating the ability to rehearse in a collaborative, positive, professional manner; and by demonstrating a high level of concentration, commitment, technical execution, listening and responsiveness during performances

PREREQUISITES:

Membership is by audition only, and requires well developed technical and musical skills on an orchestral instrument.

REQUIRED MATERIALS:

Music will be provided by the UK Symphony Orchestra. It is the responsibility of the student to bring their music, instrument (in good working order with appropriate mutes, etc.), and a pencil with eraser to all rehearsals. Music parts will be loaned to the student for the duration of the concert session, and must be returned. Music that has been checked out to a student is their responsibility, and they will be charged if it is lost, damaged, or returned late. Study scores may be required, and if so, must be purchased by the student through the UK bookstore.

REHEARSALS:

The orchestra's regular rehearsal times include Tuesday and Thursday from 3:30-6:30pm unless otherwise posted, and some Wednesdays, 7 to 10pm. Tuning will occur promptly at 3:30pm. Any student not in their seat ready to play when the A is given will be considered late for class. The rehearsal schedule will be posted on the orchestra bulletin board at least one day prior to each rehearsal. Musicians are expected to be at every rehearsal in which a piece they are playing is rehearsed. If the student is playing a work which is not scheduled for that rehearsal, attendance is not required.

Concerts and some rehearsals, such as the Dress Rehearsal, will fall outside the scheduled time for the class, and attendance is required. Musicians will be notified of these dates in advance, and institutional excuses will be provided for students who have class conflicts.

CONCERTS:

Please refer to the rehearsal and concert schedule for concert dates and times.

CONCERT ATTIRE:

Black tuxedo, (not tails): Black dinner jacket, white shirt, black bow tie, black socks, black dress shoes. Studs, cuff links, cummerbund, vest are optional.

or

Formal, all black. Full length dress; or full length skirt and blouse with jacket; or pants-suit; black nylons or socks and black dress shoes. Blouses and Jackets should have full or ¾ length sleeves.

ATTENDANCE:

Attendance is required at all rehearsals and concerts.

Excused Absences and Verification

Students need to notify the professor of absences prior to class when possible. S.R. 5.2.4.2 defines the following as acceptable reasons for excused absences: (a) serious illness, (b) illness or death of family member, (c) University-related trips, (d) major religious holidays, and (e) other circumstances found to fit "reasonable cause for nonattendance" by the professor.

Students anticipating an absence for a major religious holiday are responsible for notifying the instructor in writing of anticipated absences due to their observance of such holidays no later than the last day in the semester to add a class. Two weeks prior to the absence is reasonable, but should not be given any later. Information regarding major religious holidays may be obtained through the Ombud (859-257-3737, http://www.uky.edu/Ombud/ForStudents ExcusedAbsences.php.

Students are expected to withdraw from the class if more than 20% of the classes scheduled for the semester are missed (excused) per university policy.

Per Senate Rule 5.2.4.2, students missing any graded work due to an excused absence are responsible: for informing the Instructor of Record about their excused absence within one week following the period of the excused absence (except where prior notification is required); and for making up the missed work. The professor must give the student an opportunity to make up the work and/or the exams missed due to an excused absence, and shall do so, if feasible, during the semester in which the absence occurred.

Students may be asked to verify their absences in order for them to be considered excused. Senate Rule 5.2.4.2 states that faculty have the right to request "appropriate verification" when students claim an excused absence because of illness or death in the family. Appropriate notification of absences due to university-related trips is required prior to the absence.

MAKE UP OPPORTUNITIES: If a student has an excused absence, he or she will have the opportunity to make up the missed work.

GRADING:

The final grade will be determined by:

- 1. Professor's evaluation of each student's preparation and performance (50%) Professor's evaluation will be based on the following:
 - 1. Level of preparation for each rehearsal (50%)
 - 2. Professionalism (attitude, attention, reliability, patience, etc.) (50%)
- 2. Attendance and punctuality (40%)
- 3. Care and return of music (10%)

Grading Scale:

- 100 points (Grade: A):
 - 1. Professor's evaluation of each student's preparation and performance (50%: 50 points). Student is well prepared for all rehearsals and performances; student performs with focus and concentration in all rehearsals and performances, and exhibits a high degree of professionalism.
 - 2. Attendance and punctuality (40%: 40 points). Student has no unexcused absences from rehearsals or concerts. Student has no unexcused instances of being late for rehearsals or concerts.
- 90 points to 100 points (Grade: A):
 - 1. Professor's evaluation of each student's preparation and performance (50%: 45-50 points). Student is well prepared for almost all rehearsals and performances (8-9 of 10); student

- performs with focus and concentration, and exhibits a high degree of professionalism in all rehearsals and performances (8-9 of 10).
- 2. Attendance and punctuality (40%: 36-40 points). Student has 1-2 unexcused absences from rehearsals, and no unexcused absences from concerts, or 1-2 unexcused instances of being late for rehearsals, and no unexcused instances of being late for concerts.

80 points to 90 points (Grade: B):

- 1. Professor's evaluation of each student's preparation and performance (50%: 40-45 points). Student is adequately prepared for most rehearsals and performances (6-7 of 10); student performs with focus and concentration, and exhibits a high degree of professionalism in some rehearsals and performances (8-9 of 10).
- 2. Attendance and punctuality (40%: 32-36 points). Student has 3 unexcused absences from rehearsals, and no unexcused absences from concerts, or 3 unexcused instances of being late for rehearsals, and no unexcused instances of being late for concerts.

■ 70 points to 80 points (Grade: C):

- 1. Professor's evaluation of each student's preparation and performance (50%: 35-40 points). Student is adequately prepared for some rehearsals and performances (6-7 of 10); student performs with focus and concentration, and exhibits a high degree of professionalism in some rehearsals and performances (6-7 of 10).
- 2. Attendance and punctuality (40%: 28-32 points). Student has 4 unexcused absences from rehearsals, and no unexcused absences from concerts, or 4-5 unexcused instances of being late for rehearsals, or an unexcused instance of being late for a concert.

• 60 points to 70 points (Grade: D):

- 1. Professor's evaluation of each student's preparation and performance (50%: 30-35 points). Student is adequately prepared for about half of rehearsals and performances (5 of 10); student performs with focus, concentration and professionalism in about half of the rehearsals and performances (5 of 10).
- 2. Attendance and punctuality (40%: 24-28 points). Student has 5 unexcused absences from rehearsals, or an unexcused

absence from a concert, or 5-6 unexcused instances of being late for rehearsals, or 2 unexcused instance of being late for a concert.

- 60 points or less (Grade: E):
 - Professor's evaluation of each student's preparation and performance (50%: 0 to 30 points). Student is not adequately prepared for most rehearsals and performances; student does not perform with adequate focus, concentration and professionalism in more than half of the rehearsals and performances.
 - 2. Attendance and punctuality (40%: 24-28 points). Student has more than 5 unexcused absences from rehearsals, or an unexcused absence from a concert, or more than 6 unexcused instances of being late for rehearsals, or more than 2 unexcused instances of being late for a concert.

Care and return of music: students will receive 10 points toward their grade if music is returned on time, and in excellent condition. If music is not returned by the end of the semester, or is damaged and must be replaced, students will be billed for the replacement cost of the parts, and the 10 points will be deducted from their grade.
