- Using various other materials extracted from solfège and eurhythmics
- *Compose: Compose a tonic chord canon (10%)

This composition should be at least eight measures in length and illustrate a specific musical concept (such as note values, augmentation/diminution, complementary rhythm, or other identified musical device).

*Activity Plans: Submit three activities, in writing, for classroom use (15% of grade)

These may include eurhythmics activities (such as follows or quick-reaction activities) using folk music.

- *Discussion: Entries on the Discussion Board (10%)
- *Project: Topic to be decided and approved by your instructor (25%)

This can include sequences of lesson plans for your specific teaching situation, subject to instructor approval.

ASSESSMENT: *Written work will be evaluated with regard to thoroughness and clarity, and how well it demonstrates an understanding of the Dalcroze philosophy. Written work is submitted via Blackboard or by email. Teaching will be evaluated with regard to effectiveness and how well Dalcroze principles are incorporated.
