



#### Dear Colleagues,

I hope you are doing well as we approach the midpoint of the semester. While the recent weather has created difficulties, I always appreciate the lengthening days and warming temperatures. It is also the season for Senate elections, and elections are currently or will soon be underway in many of your colleges. I wanted to take some time to discuss the Senate, what it does, and how it works to help inform your decisions.

The University Senate is responsible for determining the broad academic policies of the University. It is also responsible for making decisions on curricula, courses, and programs and for establishing the academic calendar. It determines conditions for admission and graduation and recommends to the Board of Trustees all candidates that have been approved for degrees. It serves as a source of advice on administrative matters related to education and faculty employment and generally serves as a communication channel between the administration and the faculty, a function in which it has been particularly active during the pandemic. It is composed of elected faculty senators from the colleges as well as elected student senators and ex-officio senators.

Elected faculty senators represent you and your colleagues in the Senate and its committees. Specifically, they are expected to:

- Attend meetings of the Senate.
- Review all agenda items in advance of the meeting.
- Be mindful of the ramifications of Senate actions on their departments and colleges.
- Serve on at least one Senate committee.

When you are considering your votes for senators, consider how important this role is and vote for someone you think will exercise it carefully and be accountable to you and your colleagues. And say thank you to any of your colleagues that stand for election. This is hard and sometimes thankless work. The special role of faculty in the governance of a university is one of the key features that make a university different than other forms of enterprise and an inseparable part of the value of the institution to our students and the Commonwealth.

The Senate is meeting Monday at 3:00 pm. The Senate's business includes consideration of a number of new academic programs, changes to the Senate Rules relating to academic suspension and reinstatement, approval of a new Race and Ethnicity college requirement in the College of Arts and Sciences, extension of the test-optional admissions pilot, and discussion of the changes to undergraduate research. It is an open meeting, and all are welcome.
