

Dear Dean Blackwell:

The attached materials are in reference to the proposed changes in the Master of Social Work Program. The College of Social Work is planning to start implementing the proposed changes starting in Fall 2011, for students admitted to the Fall 2011 regular standing, 60 hour cohort. The Council on Social Work Education (CSWE), accrediting body for the College of Social Work programs, has revised its standards. The proposed changes reflect changes in the requirements of CSWE in its shift from curriculum content areas to demonstrating competencies and foundation and advanced practice behaviors. The proposed program will still require 60 hours of courses for regular standing students. The proposed advanced standing model will require 39 credit hours; the current model requires 38 credit hours. Admission and termination criteria will remain the same.

Attached you should find the Change Master's Degree Form with information on the proposed changes for the program. A summary sheet listing the courses that the program proposes to drop, change and add follows the Change Form, and the current and proposed 60 hour and advanced standing program models are also attached.



The Drop Course Forms for 7 courses, Course Change Forms for 15 courses, and New Course Forms for 11 courses are included in the packet. Per the University's plan to encourage and promote distance learning options, Distance Learning Forms are also included for each of the revised and new courses. Hybrid versions of most of the MSW current courses already exist or are in development and most of the current curriculum has been approved for distance learning.

All program and course changes have been reviewed and approved by the Curriculum Committee and Faculty of the College of Social Work. Please let me know if there is other information that I can provide. As Director of Graduate Studies, I am the contact person for the program change. The current and proposed program models are attached on a separate page, along with the lists of courses that are proposed to be dropped, changed, or added. Some of the proposed changes relate to accreditation requirements from the Council on Social Work Education, particularly in courses moving from required content areas to learning outcomes based on competencies and practice behaviors. The practice behaviors are reflected in the course syllabi. Most of the changes in the program are proposed to keep abreast of changes in the field of social work, and to incorporate more evidence-based practice throughout the curriculum. Many of the proposed changes are to increase students' ability to integrate theory and evidence based practice and appropriately apply them in practice settings. Some changes are in response to evaluation data from alumni, social service supervisors and administrators, and community partners in the off-site locations in Eastern Kentucky. The changes proposed for the foundation level courses and bridge courses are meant to better prepare students both for direct practice and to pursue their areas of concentration. The changes in the concentrations are to more clearly delineate them and to add to the advanced practice behaviors that graduates will be required to demonstrate. The proposed Community and Social Development (CSD) concentration is evolving from the current Family and Community concentration. It is proposed that the family assessment and practice course will be incorporated into the foundation coursework as part of the preparation for direct practice with individuals, families and groups. The proposed CSD concentration will better prepare graduates to understand and integrate theoretical and evidence-based macro level practice and to conduct well-informed organizational and community assessments and work to plan, develop, and administer social service resources in underserved areas. The proposed Clinical Social Work (CSD) concentration is evolving from the current Mental Health concentration. The proposed curriculum will better prepare students to incorporate theoretical and evidencebased clinical practice knowledge to make effective clinical decisions and to conduct research informed assessments and interventions with at risk children, adults, and families.
