Oral Communications Suspension "Note" Language

At the Senate Council Meeting on Monday, September 17, the Senate Council unanimously voted to send the proposed changes to *SR 5.4.3.3* ("University Studies Requirements") to the Senate with a positive recommendation, to be effective immediately upon Senate approval.

<u>Recommendation</u>: that the Senate approve the proposed changes to SR 5.4.3.3 ("University Studies Requirements") and make the changes effective immediately without further codification.

Proposal:

II. Proposed rule change to codify suspension of the oral communication requirement

At its Sept. 11, 2006 meeting, the Senate voted "to extend until Fall 2009 the suspension of the oral communications requirement." To codify this action required working with Rule 5.4.3.3 in taking this temporary suspension from a "note" in the Rule and moving it to a place where it could be easily removed, as well as other miscellaneous changes which the Rules Committee believed required submission to the Senate Council. New language is indicated by <u>underlining</u>, deleted language is indicated by [brackets], and the column entitled "Notes" provides helpful background.
