Proposal I: Degree Application Deadline for Undergraduate students only.

### Current Senate Rule Proposed Deletions Proposed Additions

**5.4.1.1 Undergraduate** Application for Degrees To be eligible for an undergraduate degree, a student must file an application with the dean of the college from which the undergraduate degree is to be awarded within thirty (30) days after the beginning of the semester or fifteen (15) days in the Summer Session in which the student expects to complete his/her work. by November 30 for graduation the following May, by April 30 for graduation the following August, and by June 30 for graduation the following December. These proposed deadlines do not apply to graduate student degrees.

### Recommended Change:

Implement the following as fixed, University-wide deadlines for filing an undergraduate degree application:

November 30 – Last day to file an undergraduate application for May graduation April 30 – Last day to file an undergraduate application for August graduation June 30 – Last day to file an undergraduate application for December graduation

#### Rationale:

The College of Arts and Sciences recommends that the following deadlines for filing an undergraduate degree application be implemented on a permanent basis: November 30 for a May graduation; April 30 for an August graduation and June 30 for a December graduation. These deadlines should remain fixed, even if they fall on a weekend or holiday.

Currently undergraduate degree application deadlines vary annually and normally fall during the semester in which students intend to graduate (*e.g.*, for AY07 the deadlines are September 21, 2006 for a December degree; February 8, 2007 for a May degree; and June 22, 2007 for an August degree). Under this system, the varying deadlines create confusion among faculty, advisors, staff and students. Such confusion leads to greater numbers of late applications. By implementing a "fixed" undergraduate application deadline the confusion is lessened, as are the annual printing costs for flyers, postcards, posters, etc.

More importantly, by moving the deadlines for undergraduate students to the semester prior to graduation (versus the current practice of filing during the semester of graduation) staff will be able to finalize term applicant lists prior to the opening of students' last semester, which will allow undergraduate students to adjust their final semester schedules if appropriate adjustments are deemed necessary. Currently, final term application lists are not available until the middle of students' final semester. Students who need to make adjustments are forced to postpone their graduation until the following semester. Changing to a fixed deadline system in the semester prior to graduation will be beneficial to these undergraduate students.

Finally, such a change will grant departmental and college staff additional time to prepare commencement awards and programs.

The rationale suggests changing the withdrawal deadline from the 9<sup>th</sup> week (i.e., four days after midterm) to the end of the 10<sup>th</sup> week. The proposal recommends a withdrawal deadline at the end of the 11<sup>th</sup> week; therefore, the rationale should be modified to avoid confusion, if possible.

Note: this proposal would change the withdrawal date to the end of the 11<sup>th</sup> week for all University of Kentucky students, including the first-time, full-time students, who now have a later withdrawal date than other students.

RE: Policy Change Proposal: application for degree deadline

Graduate Council considered the proposal from the College of Arts and Sciences to change the deadline for application for a degree to the previous semester. Graduate Council voted to recommend against this proposal.

Rationale: Council thinks there are two issues: forcing early planning on students, and making firm, recurring dates on which the application for degree is due. We do not recommend the first, but do understand and support the latter.

While Council understands the need for advisors to give early warning to students about uncompleted requirements, and to give students a full semester to enroll and finish up all coursework before anticipated graduation, we think this solution creates more problems than it solves. Many master's and doctoral students are not certain that early if they can finish the thesis. We already have a problem with the timely submission of the application cards and gathering of necessary signatures. We spend much time entering late submissions, answering pleas for inclusion, and forcing people to graduate a whole semester late. We think that the College of Arts and Sciences can require the submission of its own documents (such as the plan sheet) to force students to plan at least one semester ahead.

The Dean of the Graduate School would support the idea of setting firm dates for the submission of the cards. Such as: September 20, February 20, and June 20.
