### **COURSE DESCRIPTION:**

This course focuses on the third core public health function of monitoring health services to communities, collaborating with other health disciplines in the development and delivery of needed services, and using quality assurance activities to improve health, illness and health resources to communities. Students will learn the use of surveillance, evaluation, and performance improvement techniques in assuring cost-effective health services for communities and targeted health care environments such as home health or managed care. They will evaluate the use of nursing taxonomies for classification of aggregate level outcomes. Culturally competent care in vulnerable and multi-cultural communities and the use of informatics in assurance are emphasized.

### **COURSE OBJECTIVES:**

- 1. Evaluate the organization, accessibility, appropriateness, acceptability, cost-effectiveness and quality of personal and population-based health services.
- 2. Analyze health service performance improvement strategies in partnership with communities or targeted health care environments.

- 3. Demonstrate leadership in the evaluation of strategies to meet the priority population health needs of communities or targeted health care environments.
- 4. Evaluate health education/promotion programs to improve health, prevent disease and promote health and monitor health resource trends in communities.
- Use data management and interactive communication systems in assuring the health needs of communities.
- 6. Apply population based strategies to prevent disease and promote the health of vulnerable populations.
- 7. Utilize research findings as a basis for assuring that appropriate standards of practice are applied in meeting the health needs of a community.
- 8. Analyze the role of the community health advanced practice nurse as change agent.

### TEACHING/LEARNING METHODS:

The course will be taught using a combination of methods, including seminar, face-to-face and web-based discussion, case analysis, web-based assignments, and weekly clinical performance. Requirements for the completion of clinical expectations will be different for the certificate and the degree seeking student. For example, the certificate student, whose time is limited to 4 hours per week in clinical, might serve as a team member for an evaluation of a program, while the degree seeking student, who has 8 hours of clinical time per week, might develop an evaluation plan for a program within an agency.

### **ASSIGNMENTS:**

1. Case Study (20 points, divided as described below)

A four-part web-based case study will be used to guide students through the process of planning, implementing and analyzing a public health/community health nursing intervention. Students will discuss the case on-line in small groups and carry out indicated activities. Outcomes of the case study will be evaluated as follows:

### Case Summary and Case Analysis: (10 points)

The case study is divided into exercises. Each student will be responsible for leading online group discussion for <u>one</u> exercise and providing a written summary of the discussion on the date(s) indicated. Sample discussion questions will be included with each segment of the case.

Following Exercise 3, students will prepare a concise written analysis of the outcomes of the planning process, based on the evidence gathered during the first three segments of the case study. Instructions for the case analysis are included in Exercise 3. Students will present their analyses in class on the day the written analysis is due.

### Evaluation Design (10 points)

Following Exercise 4, each student will develop a written intervention design for the case study, based on the work plan developed by the group. Instructions for written evaluation design are included in Exercise 4.

### 2. **Informed Participation** (20%)

Students are required to participate in all class discussions, both face-to-face and electronic, in a manner that demonstrates critical thinking, synthesis of readings, and evidence of self-study. Weekly preparatory assignments and discussion topics will be posted on the web each Tuesday. Students are also expected to seek out and share current items of interest that relate to population-focused nursing practice. Students are expected to read extensively and reflect on the information prior to class discussion. Students are expected share leadership and participation in all seminar discussions with insightful comments based on the readings and relevant experiences.

### 3. **Final Presentation** (10 points)

On the last day of class, each student will present an summary of the clinical evaluation project(s) to classmates and faculty.

- 3 Advanced Public Health Nursing Clinical Practice (50 points, divided for the degree seeking student; the certificate student will NOT complete section A, but will complete the evaluation piece as described in section B below)
- A. <u>Community practice (25 points)</u>: Each student shall implement the community health nurse specialist role, <u>in partnership</u> with selected populations and personnel from clinical agencies by using appropriate theories, conceptual frameworks, and research findings to meet course objectives that pertain to the clinical settings (Objectives 1-7). Clinical practice shall address the

clinical agency's goals, objectives, and policies, as well as with related state and national health objectives, and standards of advanced nursing practice.

Standards of Practice: Clinical practice must fit with current national standards of advanced nursing practice, definitions and standards specific to the public health nursing specialty; current public health practice standards; and the current code of professional ethics for nurses.

Clinical Hours/Attendance: Each clinical semester credit is equivalent to four hours per week in the clinical setting (8 clinical hours per week are required for this course). Students may fulfill the required clinical hours each week in a time frame mutually agreeable to student, faculty, and preceptor.

Communication: Students shall keep faculty and preceptors informed verbally and in writing of weekly clinical plans and activities. Individual and group conferences will be held at regular intervals

Clinical Log: Students shall maintain a weekly log in which s/he

- 1. records clinical activities, identifies the theories, concepts, and/or evidence-based methods upon which clinical activities are based,
- 2. documents progress toward each course clinical objective,
- describes at least one theory/research-based article (annotated bibliographic format), and
- 4. analyzes the above article in relation to advanced public health nursing practice and/or the clinical practice focus.

Clinical logs are to be submitted quarterly using the digital drop box, naming each week's file: LastnameLog# (using the log numbers in place of #). Following is the format for the weekly log.

Final Presentation in Clinical Setting: Each student shall make a presentation summarizing clinical activities and recommendations to the preceptor, faculty, and appropriate stakeholders in the clinical setting. A one page summary of recommendations and appropriate visual aids should be used in the presentation.

B. Evaluation of a Public Health Program/Project (25 points for degree seeking student and 50 points for the certificate student).

Each student will evaluate a public health/community health nursing intervention or program as part of her/his clinical practice.

Prepare an oral and written report in which you summarize your evaluation of a public health program/project, using a format mutually agreed upon by the faculty, student, and clinical preceptor. The report shall include an analysis of the clinical problem(s) addressed the evaluation design, data/findings, recommendations, and actions taken (if any). Present the report to the faculty, preceptor, and appropriate members of the clinical agency and community of interest.

- C. <u>Self Evaluation</u>: At the end of the semester, each student shall submit a written self-evaluation of her/his clinical performance that includes:
  - A description of how standards of advanced practice nursing as a public health nurse specialist were met, using criteria in ANA standards for advanced nursing practice and the public health nursing specialty; and
  - An analysis of how the course and individual objectives were met through the clinical experience. This should be a concise summary developed from the weekly clinical logs.

### WHAT DOES IT MEAN TO BE A "DISTRIBUTED LEARNING" COURSE?

<u>Course Format</u>: This means that some of the course materials are available to you on the web. Inclass meetings are scheduled once each month. This does not mean, however, that the course is not interactive. For example, you will participate in several threaded discussions with other class members outside of your study group.

Internet skills: It is important to have a basic understanding of how to use the World Wide Web. If you are not comfortable with using the web, it is recommended that you take one of the workshops provided by the library.

<u>Computer Requirements:</u> This web-enhanced course requires the following computer hardware and software:
