RE: New Course

Attached please find an application for a new course. In collaboration with the UK Chandler Hospital, the College of Nursing is proposing a course for a summer clinical experience for student nurses. Students must be within 2 semesters of graduation from an accredited nursing program to participate. The course will be a clinical practice format with the students assigned to preceptors who are staff nurses at UK Chandler Hospital. Students from other nursing programs may participate as visiting students.

Courses like this are common among colleges of nursing across the country. The collaboration between hospital and college/university is important to allow students the maximum opportunity to apply nursing knowledge in a clinical setting and the seminars provide the context for feedback from faculty as students reflect on their experiences.

NUR 896: Student Nurse Academic Practicum (SNAP)

Pre-requisites:

To be considered for the selective process, students must:

- > Be currently enrolled in an accredited school of nursing.
- ➤ Have satisfactorily completed the Junior year of a BSN program or the 1st year of AND. program nursing courses with expected graduation the December or May following the SNAP experience.
- > Have a 2.75 minimum nursing course grade point average (GPA) and 2.75 cumulative GPA.
- ➤ Have a current American Heart Association Basic Life Support Certification and meet the immunization requirements of the University Hospital as determined by University Health Services.

Course Objectives:

Upon completion of this course the student will:

- 1. Safely apply acquired nursing skills and classroom theory into clinical practice using scientific principles.
- 2. Demonstrate an increased ability to analyze and synthesize client data so as to think critically and anticipate client needs.
- 3. Exhibit an increased ability to organize and prioritize client care.
- 4. Demonstrate purposeful communication and responsibility in the clinical setting, and exhibit professional behavior as an integral member of the interdisciplinary team.
- 5. Demonstrate an understanding of the health care system as a result of working with the interdisciplinary team.

Teaching Methods:

- 1. Opportunities to care for clients with RN preceptor supervision on in-patient units at UK Chandler Hospital, UK Good Samaritan Hospital, or Kentucky Children's Hospital.
- 2. Completion of a minimum of 300 hours of clinical practicum completed during the 10-week SNAP experience.
- 3. Completion of two 4-hour Clinical Reflections Seminars; one at midterm and one at the end of the experience.

Grading Criteria:

This is a pass-fail course.

Evaluation Methods:

- 1. Satisfactory midterm and final evaluations by both the clinical faculty mentor and the student's nurse preceptor. An instrument which addresses each of the course objectives will be utilized for this evaluation process.
- 2. Satisfactory attendance and active participation in the Clinical Reflections Seminars.

Criteria for Evaluation:

In order to receive credit for this course, the student must:

- 1. Satisfactorily complete all of the objectives on the evaluation tool (see attached).
- 2. Satisfactorily complete all specified course objectives.
- 3. Attend and actively participate in both Clinical Reflections Seminars.

Utilization of Blackboard:

This course utilizes the Blackboard Learning System. Students must have an active directory account to log in to Blackboard. Students needing assistance with their AD account can log onto

Clinical Reflection Seminars:

The purpose of the Clinical Reflection Seminars is to allow time for students to share and reflect upon their experiences thus far in the externship and to take part in group discussion and analysis of client scenarios that have occurred over the summer. This discussion will also include how critical thinking, management of responsibilities and professionalism have been demonstrated during that timeframe. The UK clinical instructors will be the facilitators during these seminars. There will be two (2) required 4-hour Clinical Reflection Seminars held in the College of Nursing throughout the summer (Weeks 5 & 9). Students will need to work their scheduled time with the preceptor around these times to be able to attend these sessions. Students will be paid the same for attending these seminars as they are working on the floor. The two dates for these seminars are:

- July 2 (Thur) 3:00 7:00 p.m.
- July 30 (Thur) 3:00 7:00 p.m.

Teacher/Course Evaluations:

The University policy on faculty performance review requires that faculty obtain student evaluations of teaching for every course every semester. To meet the requirement, the College of Nursing uses a webbased course evaluation. All students enrolled in this course are required to visit the Course Evaluation website to fill out evaluations or to decline the opportunity within the designated time frame. Students who don't visit the website within the designated time will receive an incomplete in the course that will remain until the website is visited. Students should take this opportunity to provide serious input regarding faculty performance and course evaluation. These evaluations are used by the College of Nursing to improve the curriculum and enhance faculty teaching. Evaluations are completely anonymous. The information is compiled and shared with individual faculty members, associate dean, and dean only after final grades are submitted.
