1. How does this course provide for timely and appropriate interaction between students and faculty and among students? Do not hesitate to ask questions or make an appointment to talk with me to discuss coursework. The Writing Center may be a good resource for assistance with paper editing, etc. It is located in W.T. Young Library and can be contacted through <http://www.uky.edu/AS/English/wc/> or 257-1356. In addition, graduate students have access to a writing specialist within the College of Nursing.

#### COURSE DESCRIPTION

This course is designed to provide a basic understanding of occupational/environmental health nursing (OEHN). The history and value of OEHN will be explored. Standards and scope of OEHN practice will be examined. The roles of OEHNs within the framework of interdisciplinary professionals will be presented. Concepts and principles will be applied through field work and topic specific assignments. Legal and ethical issues are discussed. The students will also develop the knowledge and skills necessary to appraise research and to apply evidence-based nursing practice, including up-to-date electronic resources. Students learn to apply this knowledge through field experiences.

## NUR 760-201 – FALL 2013 SYLLABUS

Prerequisite, admission to the PhD or DNP program or consent of instructor.

### OBJECTIVES

At the completion of this course, the student will be able to:

1. Explore the evolution of OEHN and applied value of OEHN practice to worker health and safety.
2. Examine the legal, ethical, and professional responsibilities of the OEHN.
3. Analyze the work environment of selected work organizations and high risk occupations.
4. Critically assess specific challenges to worker health, particularly related to central Appalachia.
5. Analyze emerging issues in OEHN and the role of the OEHN in research related to those issues.

### CLASS MEETING DATES/TIME

The course begins August XX and ends December XX. Face-to-face (FTF) class meetings in Lexington will be held in CON XXX from XXX AM to XXX PM on the following Friday mornings:

The remainder of the course will be taught via a web-enhanced format and alternative learning assignments. The on-line portion of the course will be facilitated using Blackboard (Bb), a web-based educational program. **Two field excursions will be scheduled during the semester, dates to be determined by class.**

### CONTENT OUTLINE

1. Scientific foundation of OEHN practice (including history, standards and scope of practice, emerging issues, HP 2020, NORA, etc.)
2. Workers and worker populations (including demographics and special populations of workers, emerging trends DOL, Census, etc.)
3. Legal/ethical issues (including 29 CFR, HIPAA, ADA, FMLA, DOT, OSHA, etc.)
4. Economic/political and business factors (including effects of climate on worker health, being part of the team, risk assessments, program evaluation, ROI, etc.)
5. Principles of management and leadership (including theories of management, leadership

styles, functioning in a global work environment, Lean, etc.)

6. Ergonomics/industrial hygiene (including ANSI standards, worker fatigue, injury, etc.)

7. Safety/emergency (including OSHA standards, reporting mechanisms, disaster and emergency planning, working in interdisciplinary teams, etc.)

8. Respiratory, hearing programs (including permissible exposures, surveillance, basic measures, abatement procedures, etc.)

9. Toxicology (including basics about toxicities, surveillance, symptoms, MSDS, etc.)

10. Health and wellbeing (including promotion and health counseling, expansion beyond workers to family, community, etc.)

### ASSIGNMENTS

Content 1-2: Field work using appreciative inquiry or other interview technique, interview an occupational health nurse to examine role preparation, role description, as an OHN what is the best thing they have ever done and describe how it that happened (OHN role in it), what changes they have seen in worker population over time.

Content 3: select a policy aspect (ADA, FMLA, other approved by faculty) and present a brief history of the policy and its reported effect on worker health/safety

Content 4-5: may involve field work or not, select an industry and examine its management and leadership style (this could be Toyota and Lean) interview the OEHN or person in charge of worker health/safety for how this management style impacts worker health/safety (this assignment could also be accomplished through use of literature)

Content 7-9: Field work 2 will be a risk assessment of an industrial site.

Content 10: Group Project with a small business/industry to develop a program and deliver it (example –work with UK Wellness on this assignment )

6.3.1 PLAGIARISM All academic work, written or otherwise, submitted by students to their instructors or other academic supervisors, is expected to be the result of their own thought, research, or self-expression. In cases where students feel unsure about a question of plagiarism involving their work, they are obliged to consult their instructors on the matter before submission.

When students submit work purporting to be their own, but which in any way borrows ideas, organization, wording or anything else from another source without appropriate acknowledgment of the fact, the students are guilty of plagiarism.

Plagiarism includes reproducing someone else's work, whether it be published article, chapter of a book, a paper from a friend or some file, or whatever. Plagiarism also includes the practice of employing or allowing another person to alter or revise the work which a student submits as his/her own, whoever that other person may be. Students may discuss assignments among themselves or with an instructor or tutor, but when the actual work is done, it must be done by the student, and the student alone.

When a student's assignment involves research in outside sources or information, the student must carefully acknowledge exactly what, where and how he/she has employed them. If the words of someone else are used, the student must put quotation marks around the passage in question and add an appropriate indication of its origin. Making simple changes while leaving the organization, content and phraseology intact is plagiaristic. However, nothing in these Rules shall apply to those ideas which are so generally and freely circulated as to be a part of the public domain.

6.3.2 CHEATING Cheating is defined by its general usage. It includes, but is not limited to, the wrongfully giving, taking, or presenting any information or material by a student with the intent of aiding himself/herself or another on any academic work which is considered in any way in the determination of the final grade. It is expected that students meet graduate level standards of professional writing, using appropriate wording, correct grammar, clear and cohesive presentation of material, and accurate spelling.

All papers must be submitted on the dates indicated. *Submit the paper electronically using the Bb "Assignments" site by the specified due date/time.*
