RE: Request for changes to the curriculum and courses in Physician Assistant Studies

DATE: December 11, 2007

I am attaching the proposal for changes to the Physician Assistant Studies (PAS) Program and to several PAS courses for consideration by the Health Care Colleges Council. The PAS Program is located in the Department of Clinical Sciences, College of Health Sciences. These changes were recommended for approval by the CHS Academic Affairs Committee, and I support the proposals.

The proposals are organized into three electronic folders. The explanatory narrative provided by the Program is found below.

The folder called "PAS Course Change Submission 2007 new forms" includes a request for changes in numbering of existing didactic and clinical courses with no change in the content. There is also a request to add a new course in this folder. The course PAS 678 will replace the first instance of an existing course PAS 680, which has been repeated a second time in the past. A request for change in the PAS masters program is included listing the changes in course numbering and the new course. Please see the memo for an overview.

The folder called "PAS Clinical Curriculum Changes 2007 new forms" contains requests for changes in the PA curriculum clinical year that extend beyond changes in course numbering. A request for change in the PAS masters program is included and the memo explains the rationale and what is being requested.

As stated in the previous paragraphs, both folders imply a change in the Masters Program, so a form for that change is supplied in each folder. Note that there are TWO different forms requesting a program change. This is intended to make the changes more easily comprehensible.

Re: Submission Course Changes

The Division of Physician Assistant Studies is submitting for your review multiple course changes. Several of the submissions are modifications of course numbers from professional course numbers to graduate course numbers. They are as follows:

PAS 842 to PAS 665
PAS 850 to PAS 650
PAS 851 to PAS 651
PAS 853 to PAS 653
PAS 856 to PAS 656

The lecture:lab ratio has been corrected for the following courses, and reflected in the modified course descriptions:

PAS 656, PAS 657

Additionally, one course is being created. It should be noted that this does not increase the total credit number requirements for the program. In the past, students have been required to register for PAS 680 twice; once in the didactic year, and once in the clinical phase of the program. The content of PAS 680 during the didactic year is focused on preventive medicine topics. The content of PAS 680 during the clinical phase of the program includes lectures on various special topics. It has been confusing for faculty, students, and the Graduate School to properly account for the registration of the same course number twice, and therefore we would like to assign the preventive medicine course in the didactic year a unique course number, PAS 678. The syllabus is included for your review.

II. RATIONALE FOR CHANGE(S)

If the rationale involves accreditation requirements, please include specific references to those requirements.

Two six hour required clerkships are being changed to 3 hour clerkships (Pediatrics and Surgery, PAS 661, PAS 663). Students will be allowed to select and complete two elective clerkships (3 credit hours each) under guidelines set forth by the program (PAS 842) to accommodate student preferences and future career goals. As a result of these changes the overall program hour requirements will be 97 hours. Since the program requirements already exceed graduate school and accreditation requirements there is no negative impact to the program. The change benefits both students and program.

In 2001 the UK Division of PA Studies began offering the Masters Degree. It was anticipated at that time that the curriculum would require ongoing re-evaluation and periodic revision. This proposed change reflects such an improvement through a reduction of two six credit hour (8 week) clerkships to three credit hour (four week) clerkships. While this represents an overall decrease of 6 credit hours, three credit hours will be replaced through allowing students to take PAS 842 (elective) twice. This will provide for more tailoring of their training to their future career goals. The changes will provide better training for the students by allowing for more advanced training in the area of their choice than is currently provided by the 8 week clerkships in general surgery and general pediatrics. Individualized training improves our graduates' qualifications for clinical positions.

These changes are in line with the program's long term curriculum strategy and are reflective of changes in current medical education and the medical practice environment. All course objectives will remain intact. The overall decrease in the program requirements by 3 hours (to a total of 97 hours) in no way diminishes the student's training or experience.

As a result of the program's experience with five graduating classes since 2001, certain problems have come to light. One such problem with the current 13 months of clerkships is a one month calendar overlap that is detrimental to both students and the program. This overlap between the two student classes increases competition for rotation sites and decreases the students' opportunities to be placed at the best sites. This reduction in the overall program by 3 hours will eliminate the one month overlap for our clinical year students while allowing students to customize their training.
