Why is this course being dropped?: The practical answer is: We cannot sustain the course anymore. We've been understaffed in the Comparative Politics field for years, a situation worsened by the College leveraging us into loaning these faculty members to other programs (e.g., International Studies). We're barely sustaining the other field intro, and only by having the same person willing to teach it over and over. The curricular answer is: PS 210 and PS 212 are mostly redundant, in that they offer an introduction to the field of Comparative Politics. The only thing setting them apart is that PS 210 gives more flexibility on the use of examples and applications, while PS 212 restricts them to the developing world. (That is, any PS 212 syllabus should also qualify as a PS 210 syllabus, but a PS 210 syllabus might not qualify for PS 212.) Students shouldn't be taking both courses, but rather than simply make the two courses mutually exclusive, we want to drop PS 212 because it's raison d'etre has disappeared. PS 210 couldn't qualify for the old USP Cross-Cultural requirement, necessitating the existence of PS 212, but PS 210 can (and does) meet the terms of the new UK Core Global Dynamics requirement.
