CI 722 Crisis Communication - This course follows the crisis communication management process through the stages of pre-crisis, crisis, and post-crisis. The pre-crisis stage discusses planning and environmental scanning. The crisis stage discusses communication strategies for image restoration. The post-crisis stage depicts crisis as an opportunity for organizational learning and for rebuilding or expanding public trust. The course uses a case study approach throughout. CI 721 Risk Communication - This course establishes risk communication as a distinct sub-discipline within the communication discipline. Ethical considerations are paramount in all areas covered in the course. Theories of risk communication such as mindfulness, sensemaking, chaos, image repair, issues management, the constraints of structuration, and renewal discourse are discussed in terms of pre-crisis, crisis, and postcrisis. Applied research areas such as best practices, high reliability organizations, terrorism, and health risks are also considered. CI 610 Participatory Communication – This seminar will provide students with a state of the art account of the underlying philosophical, theoretical, and methodological premises of participatory communication. This will help students gain a deep understanding of participatory communication theory and research, and their implications for such contexts as management and organizational communication, health communication, international development, journalism, democracy and civic engagement, public policy, and communication with marginalized groups.

CI 780 Special Topics in Communication – Professors will conduct research seminars in topics or problems specific to risk sciences in which they have special research interests.

CI 682 Communication and Persuasion – An advanced course examining the literature in communication and attitude change. Issues in measurement, theory, and philosophical orientation are central. Covers communication broadly, including interpersonal, mediated, and mass communication.

CI 726 Communication Leadership Studies – The primary purpose of this course is to extend students' theoretical understanding of leadership from a communication perspective. Specifically, this course is designed to (1) sharpen the students' understanding of the role of communication in developing effective leadership behaviors; (2) familiarize students with leadership as it relates to the communication process; (3) involve students in major term projects which incorporate current leadership theory and research; and (4) enhance students' understanding of published research in leadership communication.

#### Graduate Faculty Meeting Graduate Programs in Communication November 13, 2017 1:00-2:00, Niles Gallery, LCLI

- 1. Bobi Ivanov opened the meeting by welcoming everyone and thanking each for attending. This is the first meeting since September since it was agreed we would meet every other month. This was the last meeting for this semester.
- 2. The first topic on the agenda was an update on recruiting. On November 3, 2017, we held Graduate Preview Day to bring in students to learn about our program. We had increased our efforts on recruiting and had an increased number of students, and increased quality of students. This is in thanks to everyone's time and efforts participating in events and meeting with potential students when they visit campus. At the recruiting event, we had about 70 students sign up, which is about what we had last year. At any point in time, we had at least 30 students there. This year we had more students attending from schools outside of our university than we did last year, which was very positive. We also had students from other states, and we brought in more students than we were hoping for from other areas. Those who came from outside UK were primarily interested in the doctoral program. We also had quite a few of our own students from UK attending, most of whom were interested in the MA or University Scholars program, with few interested in the doctoral program.

The next big recruiting event that we have is NCA. In the interim between the recruiting event and NCA, we sent a letter with all the brochures for the areas of specialization to all the members on NCA list. In addition, some of the areas of specialization have identified feeder schools, which Bobi contacted via an additional letter specifically designed to reach those schools. This letter also invited the receiving faculty and their students to join us and inform their students to join us at the NCA fair and reception.

The next big event is NCA. Bobi sent a doodle poll to all faculty who are going, and to let him know what times they could be at either the fair or at the reception. This is important because very often students come in and are interested in a particular area of specialization, and Bobi will let the students know when they can meet with a particular faculty member in that area of specialization. Of course it always looks good when we have more people at our table and at the party rather than just Bobi alone.

3. The next topic for discussion was the prefix change for our courses. We were hoping to do one form to change all courses, but that was not the case and each course had to be changed individually. The proposal went to the Faculty Council on Friday, and it got

tabled. Bobi stated he was not sure why. Alyssa Eckman then explained that she is on the Faculty Council for ISC, and she was at the meeting. She explained that there was some type of misunderstanding that the Journalism faculty were not represented at the meeting when the change is prefix was discussed, and when the survey went out some of the JAM faculty did not receive the survey, did not know about, or did not understand it. So they objected to elimination of the "J" and the "T" from "CJT", and found it was problematic. They decided to table it pending a resolution. Bobi explained that the prefix change was discussed at a previous faculty meeting where all faculty are invited to attend. Also, it was sent to the graduate faculty listsery so all graduate faculty received the information. It's not a situation where some would get it and others would not. Either everyone gets it, or nobody gets it. Unless, you're not on the listsery, and to Bobi's knowledge all graduate faculty are on the listsery. The explanation for the prefix change is two-fold. One is that CJT is antiquated. The School of Journalism and Telecommunication changed its name, and there is not telecommunication. It is School of Journalism and Media. So that was part of it because the "T" no longer fits. The bigger part of the decision was that this is a college wide program, and the prefix should more closely match the college, and the college initials are "CI". There were 7 possible choices for prefix change, including "CJT". The survey was sent to everybody as was agreed in the meeting, everybody received it, and had the opportunity to vote. Four members of the School of Journalism and Media did vote. The majority vote was for "CI". Bobi will give an update once he gets an answer after the next meeting.

- 4. Bobi then asked for acceptance of the Minutes from the September 11, 2017 meeting. A motion was made to accept the Minutes, and seconded. There was no discussion, and it was unanimously agreed to accept the Minutes.
- 5. The next topic is where we stopped at the last meeting, and that is the graduate certificates. We spent the most time on the Risk Sciences. We discussed the topic of double-dipping. We decided that although some courses can count towards multiple certificates, students can only count one course towards one certificate.

The discussion on what courses to count in the Risk Sciences continued. On the Appendix of the agenda, the courses considered were listed. The four courses listed at the top (CJT 721, CJT 722, CJT 723, and LIS 658) are the ones still required. The proposal has been that three of the classes CJT 721 Risk, CJT 722 Crisis, and CJT 780 Special Topics such as Disaster and Terrorism (if offered), could count as two of the core courses that have to be taken. Two of these would have to be taken, and then two could come from the list at the bottom under additional courses that count towards the certificate. We have removed two Health Communication courses based on our previous discussions. The five courses in black have been there previously, and the three courses in red have been added only as considerations. CPH 662 was suggested by both Shari and Jeannette as a good possible course. The other two courses, ICT 550 and ICT 552, were discussed last time as potential courses. Bobi emailed Jeff Huber for suggestions, and these were the two courses that made the most sense. One is Security Informatics, and the other is Cybercrime and Digital Law Enforcement. We still need to hear from the Risk faculty and Crisis faculty, but those were the courses that made the most sense of what's

available. The last page of the Appendix has a description of these course (LIS 658, CPH 662, ICT 550, and ICT 552), but keep in mind that LIS 658 is already in the certificate. CPH 662 we are hoping to add, and the other two are just considerations, currently. Bobi then opened the floor for discussion on the possible courses suggested. The question was raised, what is the difference between CJT 780 Disasters and Terrorism and CPT 662 Public Health Response to Terrorism, Disaster, and Emergencies? Bobi explained that there is no CJT 780 Disasters and Terrorism, but it is a special topics and could be offered. Bobi asked for input from Jeannette and Shari, especially regarding the ICT courses if they are a good fit or not. Shari said it depends if they are graduate courses or undergraduate courses. If they are undergraduate/graduate courses, then it makes no sense, but if they are stand-alone graduate courses not available to undergraduate then she would have more support for them. She stated that she likes the content of the courses, but mixing undergraduate and graduate, and sometimes even with the university scholars, is too big of a gap to bridge. Bobi said he would check into this and get back with an answer. There were further questions about the ICT courses, and Bobi said all he knew was the descriptions. He said that Sherali Zeadally has been teaching ICT 500, and Bryce Newall will be teaching ICT 552, and he wasn't sure if that gives us any further information about the courses. There was no further discussion on these courses, so Bobi asked if there were any objections to the required courses. Shari said that she would like to propose going forward with the changes for at least two of the three for the required and the additional courses in black, and if the courses in red work out they could be substituted for one of the other additional courses once we find out more information about these courses. Bobi asked for objections, and there no objections. Bobi then said we would go with the two of the three, CJT 721, CJT 722, and CJT 780, as the required classes. As additional classes, students could take CJT 610, CJT 682, CJT 623, CJT 626, CPH 662, and LIS 658 (see Appendix for a list), with the potential of adding ICT 550, and ICT 552. For right now, we will wait on the last three courses until we get more information. Bobi then asked for a motion to accept these changes to the Risk Sciences new curricula. A motion was made and seconded. A vote was taken to replace the old curricula with the new curricula. All were in favor, there were none against, and no abstentions. Therefore, the change in curricula has been approved. Bobi will check on the other courses, and make the changes as quickly as possible.

6. The next topic for discussion was committees. There was an issue brought up by Nancy Harrington, so Bobi let Nancy explain. Nancy stated that in the past, committees had to have 5 faculty members with at least 3 full faculty. A change was made to 4 committee members, but the unintended consequence was that committees could only have one assistant professor, otherwise there would be no majority of full members. There have been incidences lately where committees were made up only one or two full members, and this has caused problems. In addition, some faculty have been serving on numerous committees. Therefore, Nancy would like to propose a change at the graduate school level to have only two full members required to be on a committee. Bobi stated the issue is not so much a problem with Master's program because only one member is required to be a full member and the other two can be the associate level. It is with the doctoral program that this is more of an issue. Bobi said before he proposes this change to the Graduate School, he need to know if there is support from our faculty. There was

discussion about faculty serving on committees. Some faculty members are more involved than others, and therefore students naturally gravitate towards those faculty members. Also, there is the student's particular interests, and finding faculty members to match those interests. Bobi explained that in order to bring in students with our interests, recruiting is the responsibility of all faculty. For the most part, there is a lot of help from all faculty. Bobi encouraged all faculty to go recruit and find their protégés. Find students interested in your area of specialization, recruit them, and you will have someone in your area to work with. Right now we have the areas of Health, Risk and Crisis, Instructional, and Strategic and Organizational as proactive. As a result, we have brochures and coursework developed for these areas. We still do not have Media and Mass Communication brochure or developed coursework. There is no area in which we have had more faculty sign up as one of their three primary areas of expertise than Media and Mass Communication (25 of our 50 faculty members). Media and Mass Communication got the most checks as an area of interest by students at the Graduate Preview Day (Strategic and Organizational was a close second). So, student interest is there, the faculty are there, and yet we have not been able to organize. So those are some of the issues we have faced in terms of the lack of balance. It takes effort and engagement. Where you see the faculty more engaged, you see the students gravitating towards that interest. The way to overcome this is by bringing in the students with greater interest in whatever the faculty's area of interest may be and preparing to recruit. The only areas so far for which we have been able to identify feeder schools due to the engagement of the faculty in these areas are Health, Risk and Crisis, and Instructional. The faculty in the other areas have not sent in any feeder schools, and the request has been sent to all areas of specialization. Anthony Limperos then asked the question if there is interest in Media and Mass Communication, why do we not have more students signing up? Do they sign up and not meet requirements or do they choose to go to other universities? Bobi explained that it is a little bit of both, but that we need to build our program and more courses to offer in order to attract students to come. Presently, there is not much to sell to potential recruits in terms of courses.

It was then decided to table this topic for now. Bobi will make some inquires with the Graduate School to find out about what is done around campus. The question was raised what the other universities are doing in regard to associate members on committees. Bobi will look into this and find out if there are other issues and complaints, and bring this to the next meeting.

7. Topics for the next meeting will include discussions on whether MA students can take their exams "in house" vs. "at home". Doctoral students can take their qualifying exams in house or at home. For Master's students, there is no provision. The Graduate School does not concern itself with that part. So, it is our decision, and we don't have anything in the rules. Last year, we said if the doctoral can then the exams at home, so should the master's students. However, it was suggested we revisit this issue. The Master's students have two hour exams, three times a week for a total of 6 hours. The Doctoral students have four-hour exam, four times a week for a total of 16 hours. The other difference is that in addition to the exam, the Doctoral students still have to write a dissertation and

defend it. The Masters students do not. So, the Doctoral students have a 4 hour exam, or 24 hours at home. The Masters students have 2 hour exam, and still get the 24 hours at home. Bobi asked that we think about this a little more, and open it for further discussion.

- 8. Bobi then asked if there was anything else to discuss. Anthony congratulated Bobi on being a prolific scholar, and everyone joined in to congratulate him.
- 9. Bobi then asked for a motion to adjourn. A motion was made, seconded, and the meeting was then adjourned.

#### LIS 658 Knowledge Management

Organizational knowledge is a valuable strategic asset. Knowledge management refers to the systematic management of an organization's knowledge assets so that they can be leveraged for sustainable advantage. This course examines how knowledge is created, captured, organized, diffused, and implemented in an organization. Topics covered include knowledge management processes and practices, corresponding technologies, collaboration tools, and people and cultural issues.

#### CPH 662 Public Health Response to Terrorism, Disasters, and Emergencies

This course will focus on the public health concepts, history, methods, planning, and response preparedness to weapons of mass destruction, terrorism, natural and human-made disasters, and other health emergencies.

#### **ICT 550 Security Informatics**

This course introduces students to policy concerns relating to security informatics, and highlights theoretical and practical approaches to designing secure information and communication technology (ICT) systems. It addresses key issues such as authentication, risk analysis, access control, database and network security, and information assurance.

#### **ICT 552 Cybercrime and Digital Law Enforcement**

The global reach of the Internet, the low marginal cost of online activity, and the relative anonymity of users have contributed to a wide escalation in cybercrimes. Consequently, information and communications technologies (ICT) are being increasingly employed to instigate threats to global civil society. This course provides an overview of cybercrime and the digital law enforcement practices put in place to respond to them. The course will focus on the types and extent of current cybercrimes, how the justice system responds to these crimes, the various constitutional protections afforded to computer users, the law and policies that govern cybercrime detection and prosecution, and related technologies.
