TA 486 Social Action Theatre

Course Description:

This course will explore the nature of community-based performance in connection with a particular community in Lexington, Kentucky or the region. Throughout the semester, the process will involve aspects of teaching, rehearsing, writing a dramatic text and performing at a community site. The assignments and projects will focus on the theory and practice of community based performance and theatre rooted in social action.

In this course, students will learn the nuts and bolts of creating a community theatre project through hands-on experiential learning.

Learning Outcomes:

- Develop the leadership skills necessary to train and lead a theatre class/rehearsal
- Increase critical thinking abilities and communication skills
- Develop a connection to community and a variety of cultures
- Help to foster an appreciation for the arts

Tentative Schedule:

Weeks 1-4: Class meets to discuss principles and practices behind the history of Social Action Theatre, with its benefits and drawbacks to participants.

Weeks 2-14: Class meets once a week to plan exercises and improvisations that will be implemented in the community project. On alternate days, the participating students will be working in the field on the community theatre project: Rehearsing, Improvisations, and Writing Script.

Weeks 14-15: Class meets twice a week to rehearse final showcase and/or performance.

Week 16: Class meets to present final papers and summarization of performance and community involvement.
