# TA 237 Acting: Scene Study

<u>Course Description</u>: An advanced lecture/laboratory course concentrating on acting techniques integral to the successful execution of scene work, including text analysis, character construction, improvisation, and stage behavior.

<u>Course Goals</u>: Upon completion of the course, students will have acquired advanced instruction in the contemporary western style of acting in the realist tradition. Successful students will be able to prepare a compelling monologue, create interesting characters, and rehearse and act appropriately in university and community productions.

<u>Learning Outcomes</u>: Through assignments and practical exercises students will acquire the theoretical and practical tools necessary to meet the course goals. Specifically, students who successfully complete the course will be able to:

- Recognize roles appropriate to their own range and type,
- Apply appropriate text analysis and character analysis for stage acting,
- Demonstrate appropriate changes in one's habits in order to create and perform a realistic character,
- Prepare a compelling monologue for performance,
- Create compelling and interesting physical choices for the execution of a scene,
- Critique acting based upon informed insight into the actor's craft.
