FALL 2021

- **August 24 – Tuesday - Class work begins**
- August 24-25–Tuesday/Wednesday - Add/Drop
- August 25 - Wednesday - Last day a student may officially drop a course or cancel registration with the university Registrar for a full refund of fees.
- September 6 - Monday - Labor Day - Academic Holiday
- September 7 – Tuesday – Monday classes meet
- September 7 - Tuesday - Last day to officially withdraw from the University or reduce course load and receive an 80% refund
- September 8 - Wednesday - Last day to add a class for the 2020 fall semester
- September 15 - Wednesday - Last day to change grading option (credit to audit or audit to credit)
- September 15 - Wednesday - Last day to drop a course without it appearing on student's transcript
- September 15 - Wednesday - Last day to officially withdraw from the University or reduce course schedule and receive a 50% refund
- September 22 - Wednesday - Last day to file an application for a December degree
- September 23- Thursday - Deadline to apply for Kentucky residency for this semester
- October 11 – Monday - Last day to withdraw from a course – Students may withdraw after this date only upon petition to the Dean's office specifying "reasons relating to extended illness or equivalent distress."
- November 24-27 - Wednesday through Saturday - Thanksgiving Holidays – Academic Holidays
- December 3 - Friday - End of class work
- December 4-6 - Saturday through Monday - Law Examination Reading Period

- January 10-11 – Monday/Tuesday - Add/Drop
- January 11 Tuesday - Last day a student may officially drop a course or cancel

- January 12- Wednesday - Last day to add a class for the 2021 Spring Semester
- January 12 - Wednesday - Last day to officially withdraw from the University or reduce course load and receive an 80 percent refund.
- January 14 – Friday - Payment deadline of registration fees
- January 17 – Monday - Martin Luther King Day - Academic Holiday
- January 26 - Wednesday - Last day to drop a course without it appearing on your transcript
- February 2 - Wednesday - Last day to officially withdraw from the University or reduce course schedule and receive a 50 percent refund
- February 3 - Thursday - Last day to file application for May degree
- February 28 - Monday - Last day to withdraw from a course –Students may withdraw after this date only upon petition to the Academic Dean’s office specifying “reasons relating to extended illness or equivalent distress”
- March 14-19 - Monday through Saturday - Spring Vacation - Academic Holidays
- April 22 - Friday - End of class work
- April 23-25 - Saturday through Monday - Law Examination Reading Period
