Sheila,

This memo is a request for a non-standard course calendar for the following PAS courses: PAS 660, PAS 669, PAS 661, PAS 671, PAS 665, PAS 662, PAS 670, PAS 664, PAS 663, and PAS 665. Each of these is a 4-week clinical rotation that occurs in the Fall for our professional students in their second year. All of our students will be in one of those courses during the time set aside for the Fall Break. Our program has contact hour and patient encounter number requirements. Missing any time during a clinical rotation places students in jeopardy of not fulfilling those requirements. Therefore, PAS Program students will not be able to leave their clinical assignments to observe the Fall Break.

Name of contact person for the proposal. Dr. Somu Chatterjee

Course prefix and number. PAS 660, PAS 669, PAS 661, PAS 671, PAS 665, PAS 662, PAS 670, PAS 664, PAS 663, and PAS 665

Proposed start and end date for the course. Start date is usually the around the 8th – 9th week of the Fall semester. The end date is 4 weeks later.

Whether the request for a nonstandard calendar is for one time only, or on a recurring basis. This request is for a waiver on a recurring basis. These clinical courses occur every Fall semester in the second year of the professional program.

The nonstandard calendar does not create an actual or potential violation of Senate Rules 5.2.2 . Students must attend their clinical assignments for at least 40 hours per week for 4 weeks. The clinical hours are accounted for in the total credits allotted to the course.
