

Section 4. Rules Relating to Admission to the University

4.1. APPLICATION FOR ADMISSION AND READMISSION

All applicants meeting the appropriate academic requirements shall be considered equally for admission to the University or to any college or academic program regardless of ~~race, color, religion, sex, marital status or national origin.~~ [US: 2/14/77] economic or social status and will not be discriminated against on the basis of race, color, ethnic origin, national origin, creed, religion, political belief, sex, sexual orientation, gender identity, gender expression, pregnancy, marital status, genetic information, age, veteran status, or physical or mental disability. All applicants for admission to the University, and all University students who have not been enrolled for one or more semesters, must submit to the ~~Admissions Office~~ of Undergraduate Admission an official application for admission and supporting documents as described ~~below in the Bulletin.~~ The Senate Rules are the source of any and all policies and rules that may be replicated in the Bulletin. The University of Kentucky adheres to admission policies promulgated by the Council on Postsecondary Education (cpe.ky.edu under Academics section) and relayed in the university Bulletin-Catalog.

~~E~~Undergraduate admission eligibility for admission to the university is housed with the individual colleges and informed through extensive and comprehensive data analyst to ensure student success. ~~This section of the university Senate rules provides guidance and policy in the administration and operationalization of the rules. In compliance with the rules and statements below~~ Senate Rules, the office responsible for Office of Undergraduate Admissions manages the operations of the admission process on behalf of the individual colleges and university.

- ~~1. Applications for admission and supporting documents must be submitted by the deadlines published in the University Calendar. However, this requirement shall not apply to University students taking summer work elsewhere who are enrolled in the University for the preceding spring and following fall semesters, except that these students must submit to the University Registrar's Office official transcripts of such summer work; [US: 4/10/2000]~~
- ~~2. professional colleges, with the approval of the Director of Admissions, may set deadlines earlier than those set generally for the University.~~
- ~~3. Applications for admission or readmission must be supported by official transcripts of all college work attempted elsewhere.~~
- ~~4. Every student whose native language is other than English and who is not a citizen of the United States [RC/transmittal: 12/9/87] is required to take the Test of English as a Foreign Language (TOEFL) prior to approval for admission. ("Native language" is defined as an individual's first acquired language of communication.) This test may be waived for such students who can present an official transcript of satisfactory work taken at an accredited American college, or a college in another country where English is the native language.~~

~~All students who present one or more units in a foreign language for entrance to the University are required to take a placement test to determine the course level at which they should begin their study of the language in the University. A student who has credit for three units of a foreign language in high school may not receive degree credit for the first year of that language in the~~

~~University. Further, a student who has credit for two units of a foreign language in high school may not receive degree credit for the first semester of that language in the University.~~

4.2. ADMISSION REQUIREMENTS

4.2.1 UNDERGRADUATE PROGRAMS

Students who satisfy the basic admission requirements may register in any undergraduate program at the University except as additional entrance requirements are hereinafter stated.

~~The University of Kentucky prefers that applicants for admission shall have taken the ACT examination. Applicants may be considered for admission, however, on the basis of Scholastic Aptitude Test (SAT) scores. The Director, Undergraduate Admissions and University Registrar shall establish annually an appropriate equivalency table of total SAT and ACT composite scores to be used with the established lower division selective admissions criteria. After approval by the Admissions Advisory Committee, this table shall be used by the Admissions Office in judging the acceptability of otherwise qualified applicants. [US: 4/8/85; 4/14/97]~~

~~All new freshman and transfer students are required to attend an Advising Conference as assigned at the time of admission unless excused by permission of the Director, Undergraduate Admissions and University Registrar in special circumstances and emergencies. [US: 2/10/86]~~

The Senate's Admissions Advisory Committee shall review the undergraduate admissions policy and all associated academic standards each academic year.

- * The status of a student being 'undeclared major' or 'non-degree-seeking' in a college is a Provost-level administrative matter and does not require the approval of the Senate, except insofar as a college may have adopted additional admissions criteria. [SREC: 1/5/2016]

Some undergraduate programs have adopted more rigorous admissions policies. These policies can be found in SR [10.4](#).

4.2.1.1 Annual Reporting

~~The Chief Enrollment Officer shall provide an annual report to the Senate at the end of each admissions cycle and preview the upcoming enrollment cycle. Timing of this annual update will occur when the Senate comes back in session in the fall and committees begin meeting.~~

~~Colleges that wish to make changes to their s All individual colleges have the responsibility of determining admissions requirements into their respective colleges/programs of study. Selective admissions policies must be data informed and reviewed/approved by colleges in accordance with college rules the Senate prior to implementation. go through the process to have them approved by the final May Senate meeting through the SAASC before May 1, should they want them to be in place for the next enrollment cycle. This is to ensure that students have full awareness before they apply about admissions policies, as well as to allow the impact of these changes on enrollment to be considered as the enrollment plan and goals for the upcoming cycle are being developed over the summer.~~

4.2.1.14.2.1.2 Basic Lower Division Selective Admissions

4.2.1.1.14.2.1.2.1 Admissions Management System Decisions

The Senate's Admissions Advisory Committee (SAAC), a standing committee of the University Senate (SR 1.4.3.3), will recommend ~~adopt~~ any changes to the admissions criterion for entry to the University Admissions Management System and go through the traditional Senate approval process for such changes.

4.2.1.1.14.2.1.2.1.1 Automatic Admissions Criteria

~~The Admissions Management System will use the automatic admissions criteria established by the SAAC. The University will publish the range of ACT and SAT scores, and grade point averages metrics, which secured admission in the previous year's freshman class.~~

~~The automatic admissions criteria will include not only high school grade point average (HSGPA), SAT, and ACT composite score, but class rank, degree of difficulty of courses, and ACT subsection scores, or any other criteria or characteristics that provide insight into an applicant's potential for academic success at the University. However, students with either an ACT score below 18 or an HSGPA which is less than 2.0 will be automatically denied admission and may be admitted only through the exceptions procedures.~~

Admissions criteria will be established according to Senate rules through the work of the SAAC and can change annually based on feedback from the chief enrollment officer from previous cycles, based on national grading trends, national admissions best practices and changes mandated through the KDE and CPE. Students that meet the established admissions criteria will be admitted. Selective college admission criteria can be found at undergraduate admissions website by searching selective majors and programs. General application and review process can be found at the main undergraduate admissions website. Students who do not meet the automatic admission criteria will be reviewed holistically and the results of this review will provide a preliminary decision for non-selective colleges to use in order to make final admission decisions. The holistic review process is a full file review of materials provided by the admissions candidate, inclusive of high school performance, as evidenced through the GPA, grade trends, strength of curriculum, test scores, involvement, leadership, and responses to the essay. Decisions for students who are denied by the colleges during the holistic review process are deferred. Decisions on students who have deferred applications will be made in mid-Spring, after a thorough review of the admitted class. Admissions criteria will be and be and students that meet the established criteria, established through data, as well as through a holistic review process will be admitted. and the results of this review will provide a preliminary decision for non-selective colleges to use in order to make final admission decisions. is a full file review of materials provided by the admissions candidate, inclusive of high school performance, as evidenced through the GPA, grade trends, strength of curriculum, test scores, involvement, leadership, and responses to the essay will provide a preliminary decision for the APP accepting colleges to use in order to make final admission decision. Students for whom the decision are deferred students who have, based on the materials provided through the application process, are deferred will go through the holistic review process. The holistic review process will provide a preliminary decision for the APP accepting colleges to use in order to make final determinations. All individual colleges have the responsibility of determining admissions requirements into their respective colleges/programs of study. High School GPA

and ACT/SAT scores are the two major pre-college academic preparation indicators used to evaluate student readiness and make admission decisions. The High School Readiness Index combines these into a single value which positively correlates with retention and student success. The HSRI = HS GPA * 10 + ACT / 2. Applicants can be automatically admitted using pre-set parameters programed through the student information system (SAP). Applicants are typically automatically admitted who have no CPE deficiencies and have achieved an HSRI of 40 or greater.

At least ninety percent (90%) of all freshman admissions will be made according to the automatic acceptance criteria.

4.2.1.1.1.2 Exceptions Procedures

Admissions criteria will contain exceptions procedures for two types of applicants. The internal exceptions procedure is for those prospective students who have certain diversity characteristics not present in the pool of students admitted by automatic admissions criteria. The external exceptions procedure is for those students whose applications for admission have been rejected under the automatic admissions criteria.

4.2.1.1.1.2.1 Internal Exceptions Procedure

The SAAC will identify characteristics not adequately represented in the pool of students admitted under the automatic admissions criteria. The Assistant Provost for Enrollment Management will forward the files of candidates having those characteristics and a reasonable academic record to the SAAC for consideration before the candidate is notified of an admissions decision. If the SAAC determines that the candidate has a reasonable chance of success, admission will be granted unless the desired class size or other critical admissions objectives have been met.

4.2.1.1.1.2.2 External Exceptions Procedure

The SAAC will continue to function as the appeals board for all candidates whose applications were rejected. Applications considered under this External Exceptions Procedure will be handled in accordance with whether or not the candidate is a freshman applicant with a HSGPA of 2.0 or higher.

The Assistant Provost for Enrollment Management will review the files of the candidates who do not meet the automatic admission criteria established by the AAC, but who offer HSGPA of 2.0 or higher. The Assistant Provost, within the exceptions parameters established by the AAC, may use his/her discretion to offer admission to freshman applicants whose credentials indicate a reasonable potential for success at the University.

A rejected applicant who is not a freshman applicant or whose HSGPA is not 2.0 or higher may petition to the AAC for admission due to, (a) significant nonacademic personal achievement; b) diversity; c) unusual situations affecting academic performance; or, (d) outstanding potential for contributing to or benefiting from an education at the University. The SAAC decision under this appeal stage constitutes the final University decision on the application.

4.2.1.3 AcaDeficiencies

4.2.1.2 Academic Preparedness and Placement

Pursuant to 13 KAR 2:020, applicants to four-year public institutions must meet the established college admission or academic readiness indicators assessments established by the Council on Post-Secondary Education and have a minimum unweighted high school GPA of: 2.5 on a 4.00 scale; or must have 2.0 to 2.49 on a 4.0 scale and enter into a learning contract with the university prior to enrollment. Students who do not meet the established CPE related thresholds in the area(s) of reading, writing or math are identified at UK as placed in the APP students (Academic Preparedness and Placement (APP)) program.

All individual colleges have the responsibility of determining admissions requirements into their respective colleges/programs of study. Five colleges accept students in the APP program as listed in the section below. If the student is denied to their applied major, the office responsible for undergraduate admission will facilitate the holistic review in collaboration with one of the non-selective the appropriate colleges, who will make final decisions on admissibility to their college. APP college.

Students who do not meet automatic admission criteria and/or do not meet one of CPE's readiness indicators, will go through holistic review in collaboration with the non-selective colleges. Agriculture, Food and Environment. For any student that applies and does not meet the selective criteria of their major choice; or falls below the automatic admissions criteria; or is APP, the student will go through a holistic review in the office of undergraduate admission. The applicant's full admissions file, as well as the results of the holistic review, will be shared with the non-selective colleges in order to make final decisions on whether to admit or deny. The colleges accepting Popen enrollment non-selective colleges will have final say on admission to students; who have gone through holistic review in the office responsible for undergraduate admission. Office of Undergraduate Admission.

The remaining eColleges which have selective criteria established by the individual college and their faculty in line with the college's rules regarding such determinations. Any changes to the admissions criteria by an individual college should be based on data and current best practices in admission; must be governed by their college rules; and go through the appropriate senate approvals. requirements. Each year, on August 1, the admissions application is opened. Once the application cycle is opened, no changes, except those which materially benefit the student, may be made. Changes which are finalized after the admissions cycle is open will be implemented for the next cycle.

Holistic Review and Exceptions

Students who are not automatically admitted based on the established criteria shall have their files reviewed in a holistic manner using a combination of the HSRI high school performance as evidenced through the gpaGPA, ACT/SAT, personal achievements, strength of schedule, grade trends and distinguishing characteristics as noted in the application for admission. Each file is read twice, and in certain cases, a third time. The The outcome of those reviews will be shared with the appropriate APP accepting colleges, in order to make final decisions on the outcome of their admissions decision.

4.2.1.2.1.14.2.1.3.1.1 Deadlines

The following admissions deadlines are established and published online on the website for Undergraduate Admission ~~https://admission.uky.edu/freshman (here)~~. The SAAC may recommend changes.:

~~November~~ December 1, for Early Decision applications
February 15, for regular, full-consideration applications
August 1, for the submission of all documents
(June 1, for participation in the summer advising conference)

~~Students who apply after the deadline for full consideration will be admitted only as enrollment goals permit. The Associate Provost for~~ Chief Enrollment Management Officer ~~will annually report to the Senate Council statistics on the incidence and number of students admitted who applied after February 15. [US: 11/13/2017]~~

These deadlines apply to both transfers and entering students. Applications received after February 15 may be rejected even if they demonstrate better qualifications than some already admitted.

~~An exemption to a final deadline prior to enrollment is made by the college from the August 1 deadline may be granted to non-degree-seeking students who enroll for no more than eight (8) credits. These students may enroll through the Evening Weekend Program, at the registration conducted before the opening of classes.~~

~~The SAAC may change these deadlines, based on future experience.~~

4.2.1.2.2.14.2.1.3.2.1 Requirements

To be admitted to the University of Kentucky under the admission policy outlined above, an applicant must have completed successfully the following high school courses as a minimum:

English/Language Arts – 4 credits required
English I, II, III, IV (or AP English)

Science – 3 credits required
Credits to include life science, physical science, and earth/space science (at least one lab course)

Mathematics – 3 credits required

Social Studies – 3 credits required

A student may substitute an integrated, applied, interdisciplinary, or higher level course within a program of study if the substituted course offers the same or greater academic rigor and the course covers or exceeds the minimum required content.

~~Rigorous electives should have academic content at least as challenging as that in courses required in the minimum high school graduation requirements. These electives also should be in social studies, science, math, English and language arts, arts and humanities, foreign language, and, above the introductory level, in agriculture, industrial technology, business, marketing, family and consumer sciences, health sciences, and technology education and career pathways. Electives in physical education and health are limited to one-half unit each.~~

~~(In addition, the University Senate recommends that high school students complete at least two years of a foreign language.)~~

4.2.1.34.2.1.4 Deficiencies

~~An applicant who is otherwise eligible for automatic admission under SR 4.2.1.1.1.1, but has no more than one course deficiency in no more than two (2) of the subject areas of the University's precollege curriculum requirement may be considered in compliance with the requirement and admitted automatically on the basis of a compensating score of 21 or higher on the ACT subtest corresponding to each subject area deficiency.~~

~~An applicant who is otherwise eligible for admission to the University and has no more than one course deficiency in no more than two (2) of the subject areas of the University's precollege curriculum requirement but does not have a compensating score of 21 or higher on the ACT subtest corresponding to each subject area deficiency may be considered for admission through the existing provisions of SR 4.2.1.1.1.~~

~~An applicant who has more than one course deficiency in any subject area or has course deficiencies in more than two (2) of the subject areas of the University's precollege curriculum requirement will be automatically rejected for admission.~~

4.2.1.3.14.2.1.4.1 High School Nongraduates

The ~~office responsible for undergraduate admission~~Admissions Committee may also consider students who have not graduated from high school ~~if they have had no previous college work but~~and can demonstrate through ACT scores, unweighted high school GPA, and other evidence that they are prepared to do the work required. These students are considered on a case-by-case basis. No student may continue to enroll as a non-degree-seeking student after earning 24 semester hours in this status without the special permission of the dean of the college in which the student is registered.

The condition of graduation from high school may be waived for superior students with appropriate recommendations from their high school counselors or teachers. The academic criteria for admission under these conditions shall be established by the ~~Director, Undergraduate Admissions~~office responsible for undergraduate admission and ~~University Registrar~~ subject to approval of ~~and revision by~~ the University Senate Council.

However, sStudents who have not graduated from high school, or received a GED, will not be eligible to Title IV funds.

4.2.1.3.24.2.1.4.2 Prospective Student Athletes Receiving Athletics-Related Aid

Student-athletes, as identified by a designee within the ~~Director~~Department of Athletics, who do not meet established standards for automatic acceptance but do meet Southeastern Athletic Conference (SEC) and National Collegiate Athletic Association (NCAA) academic requirements for freshman eligibility shall be eligible for admission. ~~Such student-athletes shall be admitted pursuant to policies established by the AAC Academic Integrity Committee.~~ Student-athletes who do not meet SEC and NCAA academic requirements for freshman eligibility may be admitted only through the provisions of SR 4.2.1.2.14.2.1.4.1, above. [US: 3/21/83 & BoT: 5/3/83; US: 4/28/86; 11/12/90; 10/11/93]

4.2.1.3.34.2.1.4.3 Transfer Students

Students at other colleges or universities will be permitted to transfer to the University of Kentucky if they meet one of the following criteria: [US: 4/10/2000]

Students who have completed 24 credit hours or more and achieved a higher education GPA of 2.00 or higher are admissible to the university. Admissibility to particular colleges or programs would be dictated by SR 4.2.1.

Students who have completed 23 credit hours or fewer must meet both freshmen and transfer admissibility requirements to gain admission to the university. The office responsible for undergraduate admission will review both final high school cumulative and postsecondary higher education GPAs in order to determine admission. Admissibility to particular colleges or programs would be dictated by SR 4.2.1. [US: 3/11/85]

~~Students who would have been automatically accepted at the time they entered the first institution attended will be allowed to transfer at any time to UK provided they have a cumulative GPA of 2.0 or better for all work attempted at the last institution attended, if they have attempted~~

at least twelve credit hours (or the equivalent thereof) at that institution. [US: 3/11/85; SREC: 11/20/87]

~~A student who would not have been automatically accepted but has completed 24 semester hours or more and achieved a cumulative GPA of 2.0 or better for all college and university work attempted and has a cumulative GPA of 2.0 or better for all work attempted at the last institution attended will be allowed to transfer to UK. [US: 3/11/85]~~

4.2.1.3.44.2.1.4.4 International Students

Undergraduate international student applicants with ~~a TOEFL an acceptable score of at least 527 (paper-based) or 71 (internet-based) may be admitted. Corresponding scores on IELTS or other approved measures of a standardized n-English proficiency shall also serve~~ test such as evidence of TOEFL, IELTS, Duolingo or other English proficiency test ~~may be admitted. Acceptable scores and test requirements for admission purposes will be posted in the university Bulletin Catalog and on the International Center website at <https://international.uky.edu/Apply/Admissions>.~~ An applicant with a TOEFL an English proficiency exam score below ~~these levels~~ the acceptable level may be admitted if other factors such as previous academic record, interviews and other English tests indicate that the applicant will be academically successful. Decisions concerning admission of applicants with scores below these levels shall be made by the office responsible for undergraduate admission Admissions Committee. International students who are otherwise admissible, but who have not yet demonstrated English proficiency, may be conditionally admitted. They will be invited to enroll in the University of Kentucky's Center for English as a Second Language (CESL), for instruction and, upon demonstrating evidence of English proficiency as defined by CESL, they will be admitted as full-time degree-seeking students. In the absence of conditional admission, admission to the programs administered by CESL does not guarantee future admission to the University. [US: 3/21/83; BoT: 5/3/83; US: 2/10/2014]

Students enrolled in Level 5 or Level 6 of CESL coursework may, upon meeting criteria set forth by the CESL program, enroll for one semester as non-degree-seeking students in a pre-matriculation bridge program (half-time enrollment in non-credit CESL coursework and 6-8 hours of credit-bearing undergraduate coursework), constituting full-time enrollment in English preparation for immigration purposes. Completion of the bridge program with grades of A or B in all classes will constitute demonstration of English proficiency for full admission to the University of Kentucky; however, some UK academic colleges and/or majors may require a TOEFL/IELTS an English language or other English proficiency exam score for admission to their programs. 4.2.1.44.2.1.5 Admission to Advanced Standing

[SREC: 6/8/2006]

Applicants for admission must present evidence that they are in good standing in every respect in the institution they last attended. At no time shall college or university records be disregarded to admit an applicant solely on the basis of the student's his/her high school records. Credit hours for courses accepted from a junior college, or other two-year colleges or branches, shall be limited to a maximum of 67 semester hours, except for the programs listed below.

1. Students in the RN-BSN (Registered Nurse to Bachelor of Science in Nursing) program, for whom the limit shall be a maximum of 90 semester hours. Applicants must have maintained a grade point average of 2.0 or an average of C in all previous course work. [US: 12/13/82; US: 5/7/2012]
2. Students in the MLT to MLS (medical laboratory technician to medical laboratory scientist) track, of the Medical Laboratory Science program, for whom the limit shall be a maximum of 80 semester hours. [US: 3/10/2014]

All collegiate level work taken at an accredited college or university is recognized credit hour for credit hour except that the dean of a college may require validation by appropriate means of course equivalencies or applicability toward degree requirements for more specialized courses. In order to be classified as accredited, a college or university must be a member of one of the six regional accrediting associations, such as the Southern Association of Colleges and Schools [Commission on Colleges](#). Advanced standing from an unaccredited US college or university may be obtained by special subject examinations. [US: 12/13/82; US: 2/11/91]

4.2.1.5-4.2.1.6 Non-degree-seeking students

[US: 10/11/93]

The goal of the University of Kentucky policy for non-degree-seeking students is to provide appropriate access to academic courses for students who would like to continue their education, but who do not wish to seek a degree. Although degree-seeking students should have top priority in terms of utilization of University resources, the University does wish to provide access to these resources on a space available basis for non-degree-seeking students. This policy will provide reasonable access to a broader range of students without unnecessarily limiting University resources for degree-seeking students.

Non-degree status affords an opportunity for individuals to pursue lifelong learning without the structure of degree-seeking status and is consistent with the educational mission of this University. [US: 10/11/93; US: 4/13/98]

Most non-degree-seeking students ~~are considered "Lifelong Learners" and include the following groups:~~ Donovan Scholars; students who have already earned degrees; and non-traditional students who wish to begin their studies as non-degree-seeking students in order to be considered for degree-seeking status later. Other students eligible to enter the University in a non-degree status include visiting students from other colleges and universities, high school students seeking dual enrollment, and other students in special circumstances as determined by the ~~person responsible for undergraduate admission~~ [Dean of Undergraduate Admission](#). [US: 10/11/93; 12/10/2018]

4.2.1.5-4.2.1.6.1 Rules Governing Admission of Non-Degree-seeking Students

[US: 10/11/93]

To be admitted as a non-degree-seeking student, an applicant must meet the following criteria: the high school class of a non-degree applicant must have graduated at least two years prior to the applicant's anticipated semester of enrollment unless:

1. The applicant will be on active military duty during his/her tenure as a non-degree-seeking student or the applicant has been admitted by exception according to SR [4.1.1.1.1.14.2.1.1.1.2](#); [US: 10/11/93]
2. The applicant is a visiting student or;
3. The applicant is seeking high school dual enrollment or;
4. The applicant possesses a bachelor's degree.
- 4.5. [The applicant is classified as a Donovan Scholar](#)

Applicants who have been denied admission as degree-seeking students may **not** in turn be enrolled as non-degree-seeking students. [US: 10/11/93; US: 4/13/98]

Former University of Kentucky degree-seeking students generally will not be enrolled as non-degree-seeking students without having earned an undergraduate degree. [US: 10/11/93; 12/10/2018]

University students under academic or disciplinary suspension at any higher education institution may not be enrolled as non-degree-seeking students. [US: 10/11/93 4/13/98; 12/10/2018]

Students currently under suspension at other institutions may not be enrolled as non-degree-seeking students at UK. Failure to disclose a current suspension may result in forfeiture of eligibility for future enrollment. [US: 10/11/93; US: 4/13/98]

Applicants are strongly encouraged to submit transcripts of prior colleges at the time of application in order to facilitate advising about appropriate coursework. [US: 10/11/93; 4/13/98; 12/0/2018]

International students applying as non-degree-seeking students whose primary physical residence will be UK, will apply using the same application process as those who are degree seeking. [US: 12/10/2018]

There are three types of non-degree students at the University of Kentucky. The first two types, visiting and high school dual enrollment students, are degree-seeking at other institutions. The third type is not seeking a degree from any institution at the time of enrollment. [US: 12/10/2018]

A visiting student is a student that is currently enrolled at another institution of higher education who intends to earn credit at UK that will be applied to degree requirements at his or her home institution. Visiting students must meet the same admission requirements as regular transfer students. Applicants will be asked to self-certify that they are in good standing at their home institution and have a minimum 2.00 GPA at the time of application. [US: 12/10/2018]

4.2.1.5.1.24.2.1.6.1.2 High School Students Seeking Dual Enrollment

Students currently enrolled in high school who desire to enroll in courses at UK must submit a high school transcript and provide a signature from a high school counselor or principal. Students may also choose to include, ACT or SAT scores as part of their application. and provide a signature from a high school counselor or principal. Students must have a minimum 2.0000 GPA and must meet the Kentucky Council on Post-Secondary Education college readiness indicators. The Next Gen Scholars program focuses on partnering with specific high schools. [US: 12/10/2018]

4.2.1.5.1.34.2.1.6.1.3 Other Non-Degree Students

These students are not currently enrolled in a degree program at a high school, college or university, but wish to take undergraduate coursework at the University of Kentucky without pursuing a formal degree. Applicants will be asked to self-certify that they have obtained a high school diploma, GED or meet the Kentucky Council on Post-Secondary Education college readiness indicators. Students wishing to change to degree-seeking status at the University of Kentucky after enrolling as a non-degree student must apply using the same application process as those who are degree seeking. 4.2.1.5.24.2.1.6.2 Rules Governing Enrollment of Non-Degree-Seeking Students

Non-degree-seeking students must meet course prerequisites or obtain the consent of the instructor to enroll in a course.

Non-degree students, ~~(except Donovan Scholars,)~~ who complete nine credit hours or more with less than a 2.00 GPA, will not be allowed to continue enrollment. [US: 12/10/2018]

No student may continue to enroll as a non-degree-seeking student after earning 24 semester hours in this status without the special permission of the dean of the college in which the student is registered.

Credit earned as a non-degree-seeking student will be evaluated for applicability toward a degree by the dean of the college in which the student will be enrolled. Successful completion of course work as a non-degree-seeking student does not ensure admission as a degree-seeking student. Students who have earned 24 semester hours at UK may apply for degree-seeking status and will be considered as transfer students for admission purposes. [US: 10/11/93; US: 4/13/98]

Admissions decision appeals are managed by the Committee on Admission by Exception Admission Appeals Committee [CD1] under the Office of Undergraduate Admissions. Using the form found on the Undergraduate Admissions webpage (<https://admission.uky.edu/admission-decision-appeals>), an applicant completes the admissions appeal form and submits the form to admissions@uky.edu following a set of guidelines published on the website. The applicant submits their appeals within two weeks of receipt of the decision and the applicant will be notified of the decision via email within two weeks of submission of the appeal.

The appeal process is specifically highlighted in the Transfer and Readmission denial letter and located on the website/provided ad hoc for Freshman applicants.

Records are purged in accordance with the University of Kentucky's record retention policy.

~~The appeals process is not a re-review of an existing applicant file and appeals will not be accepted from applicants who are not submitting new information. Appeals on admissions decisions shall follow the process below:~~

~~The appeal will only be accepted from the applicant, not a parent, guardian or spouse.~~

~~The appeal must be written and submitted within two weeks of receipt of the decision.~~

~~The appeal must present and include new and compelling information not included in the original application. Interest in attending the University of Kentucky is not a valid basis for an appeal.~~

~~The appeal must include supporting documentation noting new and compelling information.~~

~~Supporting documentation can include medical records, letters of academic recommendation, etc.~~

~~The appeal should include an explanation of why the new information was not submitted in the original application.~~
