The SAASC convened on Friday, April 13, 2018 to consider a proposal from the College of Health Sciences and College of Pharmacy involving the suspension of admissions to the PharmD/Master of Science in Physical Assistant Studies Dual Degree Program.

Procedure:

Shawn Caudill and Herman Farrell acted as facilitators of the proposal.

Discussion:

As noted in the proposal: the dual degree program was approved in 2009 and only 5 students have enrolled and one student withdrew while the 4 remaining completed the dual degree program, one successfully passed the Physician Assistant National Certification Exam "and the other three have elected not to pursue PA certification to date." The faculty in both units and colleges endorsed the suspension of the dual degree program pending further review and possible major curricular revision of the program. There were no major concerns expressed by the committee and Annie Weber noted that the suspension would last 5 years and that if no action is taken the program would be automatically eliminated.

Vote:

A motion was made and seconded that the SAASC approve the proposal from the College of Health Sciences and College of Pharmacy involving the suspension of admissions to the PharmD/Master of Science in Physical Assistant Studies Dual Degree Program.

The committee voted 7 in favor, 0 opposed.

This letter is to inform you of our programs' mutual decision to suspend admissions to the PharmD / Master of Science in Physician Assistant Studies Dual Degree Program. This decision arose from a discussion between representatives from both colleges and is supported by the faculty of our respective programs.

The dual degree program was approved in 2009 and was designed to permit a student to gain both degrees in less time than if the degrees were earned independently. It was hoped that such a program would appeal to students seeking careers in patient care, particularly those interested in becoming primary care providers.

Since the program's inception, five students have enrolled. Four completed the program and one withdrew from the dual degree but continued within the PharmD program. Out of the four students completing the dual degree, one successfully passed the Physician Assistant National Certification Exam (PANCE) and the other three have elected not to pursue PA certification to date.

Recently, the Physician Assistant Studies Program (PAS) completed a self-study review as part of its routine accreditation cycle. The Standards for Accreditation as dictated by the Accreditation Review Commission on Education for the Physician Assistant (ARC-PA) are clear in their requirement for curricular equivalency for all students participating in the PAS curriculum. Concern arose among the PAS faculty that clear curricular equivalency could not be demonstrated for several of the courses providing dual credit. In addition, the College of Pharmacy is in the process of a major curricular revision which would necessarily affect those courses overlapping in the dual degree program.

Therefore, given the relatively low number of participants in the program combined with the uncertainty surrounding current and future curricular equivalency, our programs have mutually agreed to suspend admissions as we perform further review and possible revision of the dual degree. Senate rules require some action after a one-year pause. Since changes in the PA program do not fit well for PharmD students, Dr. Smith proposes a suspension of the dual degree. A suspension of the program may last up to five years, with possibility of reinstatement. If there are changes in pharmacy practice, or renewed interest in the dual degree, the college could make adjustments in the program later. There are no PharmD students currently enrolled in the program, and the Admissions Office is not advertising it as an option. There have only been four graduates of the pharmacy dual degree, none within the last 3 years, and only one graduate took the PA board exam and practiced as a PA. A next direction may include considering a graduate certificate program, which would be available to both PharmD students and practicing pharmacists. Medical Center Library Renovation	 Mr. Davis reported that a major renovation is underway for the Medical Center Library, in response to College of Medicine feedback regarding a need for more group meeting space. There are few requests or browsing of shelves for many of the paper materials housed in the basement. After appropriate "weeding out" of long-running series of journals, most of those materials will be moved to underground storage in Wilmore. Pharmacy faculty received the original email announcing removal and have had opportunity to air any concerns regarding availability of resources. Most resources will be available electronically. The library will keep the newest versions of the more frequently requested resources available for ready reference on the first floor. Mr. Davis also reported that access to MicroMedex will be eliminated effective June 30 due to increased cost. A full version of Lexi-Comp is available now on CareWeb and will be available to all UK users on July 1. 	
Assessment Report	Assessment Committee Dr. Simpson noted that there was no formal update from the Assessment Committee. Once the assessment plan and process is in place, data collection will occur systematically.	
	Mile-Marker Exam Committee (Select Faculty Committee) Dr. Simpson recently sent a request to PY1 and PY2 course coordinators with instructions and guidelines for submitting their allotted number of items for the mile marker exams. The process is going well and is on track for the first mile marker exam in spring 2018.	
	 <u>PCOA Exam Results</u> [PowerPoint Presentation #1-attached] Dr. Simpson summarized results from the PCOA exam administered to 125 PY3 students in the Class of 2018 on January 27, 2017. There were changes in the test blueprint, question grouping, and emphasis since the exam given last year. Some residency programs were requesting PCOA scores from applicants; the programs have been told to "cease and desist" with this request. Comparison graphs will be more fully developed when there is data from subsequent years. Basic Biomedical Sciences: weak points were Biochemistry and Immunology; small number of items to make this judgement. Or. Black reported she is working with a group from six schools to track performance in biochemistry, and UK students do not do well, Some schools spend more curriculum time on biochemistry. APPE students generally report using biochemistry only in critical care or infectious disease practice settings. Pharmaceutical Sciences: weak point is Medicinal Chemistry. Social/Behavioral/Administrative: low score is in Pharmacy Law & Regulatory Affairs, yet UK students generally do very well on the MPJE (Multistate Pharmacy Jurisprudence Examination). Clinical Sciences: weak points are Clinical Pathophysiology and Clinical Pharmacogenomics. 	

 Dr. Simpson noted several simple correlations. Highest correlation is PCOA percentile with GPA in PY2 spring semester. Weak correlation of PCOA percentile to APC status; need to better parse out student status on APC list. Very weak correlation of PCOA percentile to Non-white status. When NAPLEX scores are available for the Class of 2017, she will be able to tell how PCOA scores correlate with NAPLEX scores. NAPLEX changed November 1, 2016; longer, more difficult, with more high-level application questions. Discussion: Should there be a "hook" or incentive for students to do well on the exam? Students overcame several challenges (exam on Friday, difficult exam proctors, with no incentive) and still did well, with scores ranging from 2% to 98%.
 Some schools use PCOA as mile marker exam; Dr. Simpson advises against this because the exam does not measure competency. Rewards? Starbucks card? Bonus Points? Award at annual Honors and Awards program?

(lowest score overall) • The course was helpful in developing new skills. • Red indicates items that scored low: • The answers to exam questions were explained after the exam was given.
