Dear Dr. McCormick:

The Senate Academic Organization and Structure Committee (SAOSC) recommends approval of the transfer of the Certificate in Universal Design from the Division of Undergraduate Studies, which no longer exists, to the School of Interiors in the College of Design.

This change is necessary because the Division of Undergraduate Studies was eliminated in a recent reorganization. The proposal says faculty members of the School of Interiors have been involved with the certificate since its inception, and the certificate curriculum complements the school's current and proposed curriculum. The certificate director, who is director of the Human Development Institute in the University Center on Disability, will remain the same.

Through this report, the SAOSC moves to endorse the proposal. There were no dissenting votes in the committee, which deliberated via email.

- h. Letters of support from outside the University.

Proposal to Move the Certificate in Universal Design to the College of Design School of Interiors

1. What is the impetus for the proposed change?

We propose to move the Universal Design Certificate to the School of Interiors in the College of Design, as its former unit, Undergraduate Studies, has been eliminated during recent restructuring.

2. What are the benefits and weaknesses of the proposed unit with specific emphasis on the academic merits for the proposed change?

School of Interiors faculty members have been involved with the Universal Design certificate since its inception and have expertise in this area. The Universal Design certificate content nicely complements current and proposed School of Interiors curriculum, as well as future opportunities in all of the College of Design units: architecture, historic preservation, interiors, urban design and product design (the latter two proposed but not yet reviewed).

3. Describe the organization of the current structure and how the proposed structure will be different and better. Current and proposed organizational charts are often helpful in illustrating reporting lines.

Moving the certificate to School of Interiors will allow the program to remain an option for UK students, as the Undergraduate Studies unit no longer exists.

4. How does the change fit with department, college, and/or university objectives and priorities?

The Universal Design certificate is designed to give students a foundation in the principles of universal design and its application across disciplines. Universal design utilizes a broad set of strategies that promote inclusion and participation of all people within a diverse world. The Certificate will create a focus for students' scholarly work in developing products, systems, and environments that maximize the engagement of diverse communities.

The goals of the Universal Design certificate align well with the College of Design's current curriculum and 2021 Strategic Plan, particularly Design Goal 1: Promote the Undergraduate Experience, and Design Goal 5: Elevate the Place of Design within Community Engagement + Outreach. The Universal Design certificate will provide increased opportunities for both students and faculty to collaborate across disciplines, and will increase community engagement opportunities through the certificate's practicum courses. The certificate content is unique both regionally and nationally, and will position the College of Design for growth in students, research, funding and reputation.

- 5. How does this change better position the proposers relative to state and national peers, as well as University Benchmark Institutions? How does the change help UK meet the goals of its strategic plan?**

NA. The certificate is being moved due to the elimination of Undergraduate Studies.

- 6. Who are the key personnel associated with the proposed unit? Provide qualifications of these personnel in a brief form. A complete curriculum vitae for each person is not needed, although pertinent information in tabular format is helpful.**

Kathy Sheppard-Jones, HDI Executive Director and Director of the Certificate, and Elaine Eisenbaum, HDI Training Director, will provide oversight of the Universal Design Certificate.

Dr. Allison Carll-White and Prof. Christina Birkentall will both continue their ongoing relationship with HDI. Patrick Lee Lucas serves as Director of the School of Interiors. All three individuals bring useful perspectives to universal design in the academy and in professional practice.

- 7. Discuss leadership and selection process for appointing a chair, a director, or interim leader and search process, etc.**

Dr. Kathy Sheppard-Jones continues to be the Universal Design certificate director. When the need for a new certificate director arises, the HDI Executive Director, in consultation with the Director of the School of Interiors, will appoint a new director.

- 8. What is the function of the faculty/staff associated with the proposed change and how is that relationship defined? Discuss DOE, adjunct, full-time, voting rights, etc.**

Moving the certificate to the School of Interiors will not result in any new hires or changes in voting rights. The director's time will continue to be paid by HDI.

- 9. Will the proposed change involve multiple schools or colleges?**

The certificate will remain available to students from all UK colleges. The director will continue to market the Certificate to faculty and students across colleges.

- 10. If the proposed change will involve transferring personnel from one unit to another, provide evidence that the donor unit is willing and able to release the personnel.**

NA. No transfers of personnel will occur.

- 11. What is the arrangement of faculty associated with the proposed change and how is that relationship defined? Discuss faculty DOE and status as adjunct, tenure track, or**

NA – No faculty changes will occur as a result of this move.

13. What is the timeline for key events in the proposed change? Student enrollments, graduates, moved programs, closed courses, new faculty and staff hires, etc.

Ideally, the Universal Design certificate would be transferred to the School of Interiors by Fall 2018. The director is currently recruiting students for next year's cohort.

14. If the proposal involves degree changes*, describe how the proposed structure will enhance students' education and make them more competitive. Discuss the impact on current and future students. Transfer of the program should incur no additional costs. HDI will continue to cover the Universal Design certificate director effort and provide a budget for recruitment materials. HDI and the School of Interiors may provide funds to sponsor co-curricular events.

The faculty of the School of Interiors met on Wednesday, 21 March 2018 and voted to endorse the School serving as the academic headquarters for the undergraduate Universal Design Certificate. Of the 11 eligible faculty members, 11 voted for the proposal and 0 against. The

discussion regarding this matter has been recorded in the minutes of the faculty meeting and is appended to this proposal form.

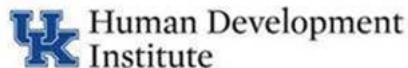




Dear Dr. McCormick,
