I am writing to express my full support for the proposal to change the name of the Department of Early Childhood, Special Education, and Rehabilitation Counseling (EDSRC) in the College of Education to Early Childhood, Special Education, and Counselor Education (EDSCE). The documents submitted to support this proposal describe the reasons and rationale for this request. In addition, to my support the proposal has been reviewed and approved by the Department and by the College Courses and Curricula committee.

There are several reasons for this request. Between 1981 and July 01, 2017 the Rehabilitation Counseling (RC) program was accredited by the Council on Rehabilitation Education (CORE). On July 01, 2017 CORE merged with the Council on Accreditation of Counseling and Accredited Educational Programs. Our CORE accredited Rehabilitation Counseling program automatically converted to a CACREP accredited Rehabilitation Counseling program.

As I understand, the current name of the department does not reflect the doctoral Counselor Education and Supervision and master's Clinical Mental Health program, which are housed in this department. This name change remediates this problem by creating an umbrella through which our counseling programs will be under. This will aid in recruiting as applicants will not be misled into thinking that we only have a master's Rehabilitation Counseling program and not a Clinical Mental Health and a doctoral Counselor Education and Supervision program.

This change is not duplicative of other programs in this college or as I understand other program on the University of Kentucky campus. Thus, it has my complete support. As always, I am available if questions arise. Thank you for consideration of this department name change request.

Request for Name Change for the Department of Early Childhood, Special Education and Rehabilitation Counseling (EDSRC) to the Department of Early Childhood, Special Education, and Counselor Education (EDSCE)

1. What is the impetus for the proposed change?

There are several reasons for this request. Between 1981 and July 01, 2017 the Rehabilitation Counseling (RC) program was accredited by the Council on Rehabilitation Education (CORE). On July 01, 2017 CORE merged with the Council on Accreditation of Counseling and Accredited Educational Programs. Our CORE accredited Rehabilitation Counseling program automatically converted to a CACREP accredited Rehabilitation Counseling program.

Doctoral programs were not accredited by CORE. However, CACREP does accredit doctoral programs and we submitted an accreditation packet to CACREP for our doctoral program in Counselor Education and Supervision, which was reviewed, and the doctoral program was accredited effective July 13, 2017.

Also, CORE did not accredit mental health counseling programs whereas CACREP does. The Rehabilitation Counseling program faculty are in the process of preparing an accreditation program packet for a master's degree in Clinical Mental Health Counseling.

This program will align with state requirements throughout the nation for licensure as a licensed professional counselor. The program requirements and associated courses for the Clinical Mental Health program are being reviewed separately by the appropriate university committees.

2. What are the benefits and weaknesses of the proposed unit with specific emphasis on the academic merits for the proposed change?

The current name of the department does not reflect the doctoral Counselor Education and Supervision and master's Clinical Mental Health program. This name change remediates that problem by creating an umbrella by which our counseling programs will be under. This will aid in recruiting as applicants will not be misled into thinking that we only have a master's Rehabilitation Counseling program and not a Clinical Mental Health and a doctoral Counselor Education and Supervision program.

3. Describe the organization of the current structure and how the proposed structure will be different and better. Current and proposed organizational charts are often helpful in illustrating reporting lines.

The EDSRC has three distinct programs (Special Education, Rehabilitation Counseling, and Interdisciplinary Early Childhood). Each program has its own program faculty to deal with

recruitment, admission, retention, certification, and exit issues. Each has its own advisors, distinct faculty members with distribution of effort dedicated the program, and Director of Graduate Studies. Changing the name of the program will not change the current structure of the department but will better reflect it, and in particular the counseling programs in the department.

4. How does the change fit with department, college, and/or university objectives and priorities?

As a land grant institution, the three accredited counseling programs fit the university land grant mission. The change will better reflect the two additional counseling accreditations.

5. How does this change better position the proposers relative to state and national peers, as well as University Benchmark Institutions? How does the change help UK meet the goals of its strategic plan?

The name change will make it more apparent that there is more than one counseling program within the department. Also, within the Counselor Education part of the department there is now an undergraduate Disability Studies program. There is not an accreditation available for undergraduate programs of this nature, there is however, a registry for such programs.

6. Who are the key personnel associated with the proposed unit? Provide qualifications of these personnel in a brief form. A curriculum vitae for each person is not needed, although pertinent information in tabular format is helpful.

The faculty who teach in each of the Counselor Education programs are listed below with the Program Faculty Chair/Director of Graduate Studies identified. Each of these faculty members holds a terminal degree in rehabilitation and counselor education. The table shows the structure of the counseling programs:

7. Discuss leadership and selection process for appointing a chair, a director, or interim leader and search process, etc.

The chair is recommended by a committee that includes a representative from each program area; the Dean of the College of Education makes the final selection.

8. What is the function of the faculty/staff associated with the proposed change and how is that relationship defined? Discuss DOE, adjunct, full- or part-time, voting rights, etc.

All identified faculty are full time with a 100% DOE. Each department faculty member of each counseling program is a voting member in the department and counseling programs. Each program faculty member is a voting member in the program to which he or she is assigned. All hold DOE to teach courses in their assigned programs. Some faculty members teach core courses across programs that are required by all students in the undergraduate, master's, and doctoral programs.

The Counselor Education programs also have two doctoral level Adjunct Professors, Dr. Kathy Sheppard-Jones, who is Director of the University Human Development Institute and Dr. David Beach who is the Director of the university Disability Resource Center. Both teach courses in the master's programs and can service of committees. Faculty are as follows:

The name change will not affect other schools or colleges. There is no overlap or duplication between programs in this department and any other program or department in the College of Education or the university.

11. What is the arrangement of faculty associated with the proposed change and how is that relationship defined? Discuss faculty DOE and status as adjunct, tenure track, or tenured. Describe the level of faculty input in the policy-making process including voting rights and advisory.

The name change came as a request from the Counseling program. Changing the title of the department as recommended reflects the inclusion of three accredited program in counseling

under one program/department title (Counselor Education), two at the master's degree level and one at the doctoral degree level. This proposed change was reviewed and unanimously approved by the Rehabilitation Counseling faculty in March and early April 2019 and reviewed and unanimously approved by the department faculty at the April 02, 2019 department meeting.

12. Discuss any implications of the proposal for accreditation by SACS and/or other organizations.

The proposed name change will make the programs covered in the Counseling Education part of the department clear to accrediting agencies, including SACS and the Counseling accrediting agency, the Council on Accreditation of Counseling and Related Educational Programs (CACREP). Websites and reports should be easier to find trough a key word search.

13. What is the timeline for key events in the proposed change? Student enrollments, graduates, moved programs, closed courses, new faculty and staff hires, etc.

A key event is the reaccreditation of the master's Rehabilitation Counseling program and the doctoral Counselor Education and Supervision programs which will occur in the Fall of 2021 and the new accreditation review of the Clinical Mental Health Counseling program, which will also occur during the Fall of 2021. Please note that the program description packets for all three accreditation reviews are due in the CACREP office by July 01, 2020. An effective date of January 01, 2020 is requested to insure compliance with the accreditation timeline.

It is requested that the letters EDSRC that represent the department change to EDSCE to reflect the inclusion of the three counseling programs. It is noted that courses listed by program prefixes: (a) IEC = Interdisciplinary Early Childhood and (b) EDS = Special Education will remain the same.

The request to change RC from Rehabilitation Counseling to CE (Counselor Education) is inclusive of the three counseling programs, master's Rehabilitation Counseling, master's Clinical Mental Health Counseling, and doctoral Counselor Education and Supervision.

14. Proposals involving degree changes and students to make them more competitive:

All three programs areas (IECE, EDS, and CE) will now appear in the department name listed on students' diplomas and transcripts. This should be an advantage to students who are searching for jobs and applying to graduate programs. Also, a separate request has been submitted to the university and Senate to change the master's degree form Master of Rehabilitation Counseling to Master of Arts, which is more reflective of the two master's degree programs.

It should be noted that SACS require a terminal degree in the field in which candidates teach. This will allow our doctoral students in Counselor Education and Supervision from a department that identifies their program by name.

The name change will allow our Early Childhood program to be more competitive in grant writing for early childhood funds and the recruitment of students.

15. Financial Resources

Additional financial resources are not required for this change. All programs have been or are being approved through appropriate university channels. Faculty are appointed to oversee, manage, and teach in the counseling programs identified. Letters of support as appropriate will be provided.

16. Faculty Votes

This proposed change was reviewed and unanimously approved by the Rehabilitation Counseling faculty in March and early April 2019 and reviewed and unanimously approved by the department faculty at the April 02, 2019 department meeting.

Following approvals at the College level, this proposal is forwarded to Ms. Sheila Brothers, administrator with the Office of the Senate Council. This proposal does not go into Curriculog but at your discretion can be referred to the Courses and Curricula Committee and the Council of Chairs for review and a recommendation for the College faculty to consider. A letter from you as Dean following approval at the College level would be appropriate.

17. Letters from Faculty and Administrative Personnel

Letters from the Dean and senior College and Senior Department faculty will be provided.

18. Evaluation of the New Structure

A key evaluation event is the reaccreditation of the master's Rehabilitation Counseling program and the doctoral Counselor Education and Supervision programs which will occur in the Fall of 2021 and the new accreditation review of the Clinical Mental Health Counseling program, which will also occur during the Fall of 2021. Please note that the program description packets for all three accreditation reviews are due in the CACREP office by July 01, 2020.

From Education Policy Studies and Evaluation

Major Course Change - EPE 628 Ethics in Educational Decision Making

Rationale: The intention is to offer this course as a distance learning class, especially to address demand for it from students in programs with many students who only take courses online, such as in Educational Leadership.

Course Description. This course concerns major moral challenges for leadership in educational decision making. These include conflicts between religion and ethics, as well as the responsibilities of and for education in democratic societies. We will draw on resources from bioethics and ethical norms that have arisen in relation to the performance of research on human subjects to examine and reveal the ways in which historical norms are applied, updated, challenged, and revised in the light of new democratic contexts, particularly applied to the contexts of colleges and schools. We will review dominant moral theories and how they various apply or conflict with modern norms, yet continue to inspire divergent outlooks on education. We will then conclude the course with focus on particular contexts for challenges in democratic societies, such as with regard to integration and self-segregation, conflicts of interest, challenges for teachers, administrators, and testing in schools, as well as with regard to special education.

Course Change with Core - EPE 174 Theories of College Student Success

Major Change, Major – Add Distance Learning

Rationale: We have worked on updating and rebranding the course for use in the College of Education First Year Experience curriculum and as a basic general education course. Minor Course Change - EDS 530 Moderate and Severe Disabilities

Type of Change Being Proposed: Change in prerequisite(s) which does not imply a change in course content or emphasis, or which is made necessary by the elimination or significant alteration of a prerequisite(s)

Rationale: This course was originally proposed with a pre-requisite of Junior or Senior standing and a co-requisite of EDS 301 (Initial Practicum in Special Education). The reality is, we have students taking this course as sophomores, so the real pre-requisite is our introduction to Special Education course (EDS 375). In regards to the co-requisite, because this class is taken by students outside the Special Education program, we are having to override or remove the co-requisite every time the course is taught. This change will not result in any changes to the content of the course (the students will still be required to do the same work and practicum observations as before, they just won't be required to be enrolled in EDS 301 at the same time).

Course Description: Special education issues with individuals exhibiting moderate to severe intellectual and developmental disabilities. A critical examination of contemporary research with regard to the educational, behavioral, developmental issues of individuals exhibiting moderate to severe intellectual and developmental disabilities. Issues and research describing the full educational inclusion and community integration of persons with moderate to severe intellectual and developmental disabilities will be addressed.

Major Course Change – EDS 605 Practical Applications of Applied Behavior Analysis

Rationale: Adding Distance Learning so the course aligns with the rest of our program.

Course Description: In this course students will expand their understanding of Applied Behavior Analysis (ABA) by learning how to design and evaluate behaviorally based programs that address academic (e.g., learning to learn), adaptive (e.g., self-care), communication (e.g., naturalistic strategies; verbal behavior), social (e.g., initiations), and other related skills (e.g., self-management) in persons with or at-risk for disabilities and provide training and feedback when working with families and professionals. Also, students will receive training on coaching and training adults.

New Course Proposal – EDS 617 Professional Ethics For Behavior Analysts

Rationale: In the current approved program there are three separate one-hour courses related to ethics for behavior analysts (a minimum of three credit hours is required to be considered a Verified Course Sequence from the Behavior Analysts Certification Board). The proposed change would collapse the three one-hour courses (EDS 614, EDS 615, EDS 616) into a single three-hour course (EDS 617). The original sequence of courses was designed to be manageable for the few faculty eligible to teach these courses. Since the original sequence, additional faculty have been hired.

Course Description: This three-hour course is designed to address ethical, behavioral, and professional conduct for behavior analysts. This course will address content related to the Analyst Certification Board (BACB) Professional and Ethical Compliance Code for Behavior Analysts. This course is required for students who plan to sit for the Board Certified Behavior Analyst (BCBA) exam.

Department Name Change Proposal - EDSRC Department Name Change to EDSCE

Program Change Proposal - IECE Bachelors Degree Change

We are also requesting that IEC 512 - Language and Literacy for Young Children be changed from a TEP restricted course to a non-TEP restricted course; meaning that students are not required to be admitted into TEP prior to taking this course. New Program Proposal – Teachers of the Visually Impaired New Masters Degree

Brief Description: The Teacher Preparation Program in Visual Impairments is designed to train Teachers of the Visually Impaired (TVIs) to work with children from preschool through graduation who are blind and visually impaired, including those with and without additional disabilities. TVIs modify instruction and materials for students to gain access to the core curriculum, as well as teach the expanded core curriculum, which consist if nine specific skill areas such as assistive technology, independent living, and sensory efficiency that are needed for

post-graduation success. The current TVI certification program consists of three tracks, one for initial teaching candidates, one for initial teaching candidates that are employed as a TVI while enrolled in the program (alternate certification), and the last for those candidates who already hold a teaching degree and/or certification in another area. The master's degree will be inclusive to all three of these certification programs and will consist of the core Visual Impairment (VI) classes. The TVI program uses a hybrid model with synchronous classes offered via Zoom, face-to-face weekends, and intensive summer courses held at University of Kentucky and Kentucky School for the Blind (KSB) in Louisville. There are ten core VI classes for the program that focus specifically on visual impairments, the final one consisting of student teaching or field experience. The total credit hours for the degree program is 33. It should be noted that the degree requirements are different from Kentucky teacher certification requirements, which may require additional coursework.

Rationale: The current teacher certification program has been in high demand, as UK is the only university in Kentucky that trains Teachers of the Visually Impaired (TVIs). As of August 2019, the program has certified 59 TVIs since it started in 2013 and has another 38 currently enrolled in the program. Each cohort has been running at or above capacity due to the severe shortages in this area, as indicated by the Kentucky Department of Education's (KDE) critical shortage area list. In addition, over 95% of the teacher candidates in the program were employed as their school district's TVI while completing the program, since no fully certified TVIs were available. This shortage of TVIs extends nationally, as there is a critical shortage across the U.S.

This memo is to provide background information for a request that the name of the "Department of Early Childhood, Special Education and Rehabilitation Counseling" be changed to the "Department of Early Childhood, Special Education, and Counselor Education." An effective date of January 01, 2020 is requested. Making this change will impact the EDSRC abbreviation currently used for the department.

However, the underlying change will only impact the Rehabilitation Counseling program. The proposed department abbreviation is, EDSCE and the prefix used for counseling courses changed from RC to CED. No change to the Early Childhood, Special Education, or Visual Impairment programs or courses will be made and this will not affect the names of degrees or majors within Early Childhood, Special Education, or Visual Impairment programs within the department.

There are several reasons for this request. Between 1981 and July 01, 2017 the Rehabilitation Counseling (RC) program was accredited by the Council on Rehabilitation Education (CORE). On July 01, 2017 CORE merged with the Council on Accreditation of Counseling and Accredited Educational Programs. Our CORE accredited Rehabilitation Counseling program converted to a CACREP accredited Rehabilitation Counseling program.

Doctoral programs were not accredited by CORE. However, CACREP does accredit doctoral programs and we submitted an accreditation packet to CACREP for our doctoral program in Counselor Education and Supervision, which was reviewed and the program was accredited effective July 13, 2017.

Also, CORE did not accredit mental health counseling programs whereas CACREP does. The Rehabilitation Counseling program faculty are in the process of preparing an accreditation program packet for a master's degree in Clinical Mental Health Counseling. This program will align with state requirements throughout the nation for licensure as a licensed professional counselor. The program requirements and associated courses for the Clinical Mental Health program are being reviewed separately by the appropriate university committees.

In summary, under the current structure of the Rehabilitation Counseling program we have an accredited master's program in Rehabilitation Counseling and an accredited doctoral program in Counselor Education and Supervision. Under the proposed structure (umbrella) there Julian Vasquez Heilig Dean, College of Education July 01, 2019 Page 2

will be an accredited master's degree program in Rehabilitation Counseling and an accredited doctoral program in Counselor Education and Supervision. We also have a college, university, and Council on Post-Secondary approved bachelor's degree program in Disability Studies within the Counselor Education structure. This is not an accredited program.

We anticipate adding a second accredited master's degree program in Clinical Mental Health Counseling by Fall 2020. This will coincide with the reaccreditation of our current master's and doctoral programs due to be reviewed for reaccreditation by Fall 2021.

Changing the title of the department as recommended reflects the inclusion of three accredited program in counseling under one program/department title (Counselor Education), two at the master's degree level and one at the doctoral degree level. This proposed change was reviewed and unanimously approved by the Rehabilitation Counseling faculty in March and early April 2019 and reviewed and unanimously approved by the department faculty at the April 02, 2019 department meeting.

Following approvals at the College level, this proposal is forwarded to Ms. Sheila Brothers, administrator with the Office of the Senate Council. This proposal does not go into Curriculog but at your discretion can be referred to the Courses and Curricula Committee for review and a recommendation for the College faculty to consider. A letter from you as Dean following approvals would be appropriate.

Paper work required to be submitted to the university for this change is provided for your review. It is my understanding that for this change to be effective for the 2020-2021 academic year (effective January 01, 2020) it will need to be reviewed by the University Senate no later than mid-November 2019.
